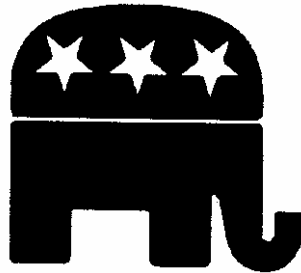
Also included are the party emblems for the Democratic, Republican, Libertarian and Constitution parties.

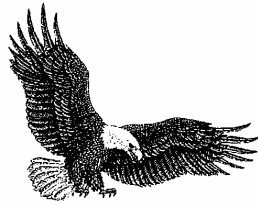
