The meeting was called to order at 1:30PM and roll call was taken.

Boone County Clerk

1. First and second Reading: Accepting the election results from the April 2, 2024 special election

Boone County Clerk Brianna Lennon stated there was an election on April 2nd, and on Friday of that week, certification of that election was conducted. Clerk Lennon stated a bipartisan election judge team comes into the office and adjudicates all the provisional ballots (of which there were forty); they count any absentee ballots that came in by the deadline, and they do a hand count audit of 5% of the precinct ballots to make sure the election equipment properly tabulated the ballots cast on election night. Clerk Lennon stated all those things matched and they certified the election with 16.37% voter turnout. Clerk Lennon stated the reason it's on the agenda today is because Proposition 1 for Boone County was on the ballot and did pass, so this is an

acceptance of those results and reading it into the minutes to make sure we are appropriately accounting for the results.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby accept the attached certification of election from the County Clerk and Local Election Authority for Boone County, Missouri, relating to the April 2, 2024 Special Election.

Purchasing requests approval of contract C000770 using the Texas Department of Information Resources co-operative contract DIR-TSO-3996 for IBM Branded Products and Services with Huber & Associates of Jefferson City, Missouri for the Boone County Information Technology Department.

The Information Technology Department wishes to purchase renewals for maintenance on a variety of IBM software licenses to span from April 06, 2024 through April 05, 2025 for 24X7 support.

The contract period will run from April 02, 2024 through May 10, 2024. The maintenance renewal will be purchased within this period, but the resulting annual license will survive beyond the May 10th end date for the contract.
