### **Health Department**

## 2. Agreement with Youth Community Coalition to conduct compliance checks (first reading)

Boone County Sheriff Capt. Gary German spoke to this issue. He stated this is a continuing effort with the Youth community Coalition. The State of Missouri had cut the funding but has now reinstated with funds of \$4,000.00 to pay for equipment and salaries. Also, past failures were in the 50-60 % range, now at 25%. Capt. German said there is always an effort to contact owners and express gratitude for participating.

Commissioner Miller asked about failures.

Capt. German said they are usually issued a summons for sales to underage and a report is filed with the Liquor Control.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available Commission meeting with an appropriate order for approval.

## 3. Cyber Crimes Grant Application (first reading)

Grant application is for the period 3/1 - 5/31, a three month period to coincide with the fiscal cycle since this Federal program will be switching to State control. There will be a reapplication with the State for full year funding. There are no changes to the program and no changes to the associated costs. Overtime costs were discontinued and there will be a request to reinstate these costs.

Commissioner Miller asked if there are any costs to the County and the response was no.
