Sheriff's Department

1. Budget Amendment to supplement a prior approved budget amendment for the Sheriff's department facility camera system. (2nd reading, 1st read 11-06-12)

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the following budget amendment to supplement a prior approved budget amendment for the Sheriff's department facility camera system. Replace Machinery & Equipment; increase \$11,746.00, Computer hardware; increase \$7,843.00, computer software; increase \$140.00, Minor Equipment & Tools; increase \$4,095.00. Total increase: \$23,824.00.

2. Recognition of retiring K-9 service dog's contributions and retirement (Utz)

Commissioner Atwill cited recognition of K-9 service dog Utz for contributions to the community and retirement in a letter. The following proclamation was read:

(Whereas) Boone County K9, Utz, and Deputy Chris Smith worked together for over ten years, June 10, 2002 – October 6, 2012.

(Whereas) Utz and Deputy Smith trained together for over 2,000 hours, creating a highly skilled and successful team.

(Whereas) In the line of duty, Deputy Smith deployed K9 Utz over 2,000 times.

(Whereas) During that time, utilizing Utz's superior tracking abilities, they located and apprehended over 70 subjects. Several of these tracks were for distances well over a mile.

(Whereas) Utz and Deputy Smith had over 100 narcotics finds from traffic stops and building searches to include various amounts of marijuana, methamphetamine, cocaine and heroin.

(Whereas) Utz and Deputy Smith located discarded firearms and assisted with the recovery of stolen property.

(Whereas) Utz and Deputy Smith performed over 100 demonstrations to the public in an effort to educate and serve the community.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby accept the attached proclamation honoring K-9 Police Service Dog, Utz, for many years of service to the community. It is further ordered the Boone County Commissioners are hereby authorized to sign said proclamation.

Cost of the contract is \$453,711.00. There will be a 10% contingency of \$45,371.10 added for a Purchase Order total of \$499,082.10 which will be paid from department 2045– Public Works – Design and Construction, account 71100 – Contractor Costs. \$800,000.00 was budgeted for this project.

Commissioners Atwill, Miller and Elkin discussed details of the project with Ms. Bobbitt and what costs are included in the total project.
