The meeting was called to order at 9:34 a.m.

Department of Public Health

1. 1st & 2nd reading; Abatement of a property located at 4480 Hinkson Creek Road, parcel #12-801-28-00-002.00 01

Kala Wekenborg said that they have received complaints from several neighbors on the property. She has spoken with the owner and thought she might be here for the meeting to request an extension but she is not here. The owner is an elderly lady, widowed about two years ago with limited funds. The property has been vacant for several years and the daughter said that the property is up for auction in August. They are not sure how the property got in its' current condition. At present, the property is littered with insulation and building materials as well as an overturned vehicle. A bid received has clean-up at \$375.00 plus the towing of the vehicle at a minimum of \$125.00

Commissioner Atwill asked Ms. Wekenborg to explain to the 4-H members in attendance what an abatement is and what the County is about to do to resolve this issue.

Ms. Wekenborg addressed the 4-H members explaining the various reasons for an abatement and the process to execute the abatement. She mentioned that it is a County wide effort where they not only work with the Commission, but also the Prosecutor's Office and the Sheriff's Department. Costs associated with the execution of the abatement are added to the owners property tax bill.

Commissioner Atwill congratulated Ms. Wekenborg on a job well done explaining the abatement process.

2. Second reading; Long Distance Contract with Century Link (1st reading 5-2-13)

Prosecutor's Office

5. First reading; VOCA (Victims of Crime Act) Grant Application Approval

Prosecuting Attorney Daniel Knight said they are requesting approval for the Victims of Crime Act grant for our response team through the Department of Public Safety. They have been receiving these funds since 1993. The grant will be used for the salary and benefits for the departments case specialist. Currently this is a part-time, non-benefited position and we would like to make it a full-time, benefited position. This is a two year grant cycle, October 1, 2013 through September 30, 2015.

Mr. Knight also stated that the Federal share is \$118,561.42 and the local match is 29,985.75 taken from the existing salary of the victims specialist. The person we want to hire will be working on serious violent crimes, those which our office gives high priority. We handle over 3,000 victims of crime each year and this person will assist in this endeavor. There will be no budgetary impact to the County. Since this is an electronic grant, we will need permission to type in the Presiding Commissioners name on the web grant.

The Commissioners concurred and Commissioner Miller asked that when the Commission Order is drafted, that it be noted that permission will be granted to type in the Presiding Commissioner's name on the web grant.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County

Clerk to schedule this item for a second reading at the next available commission meeting

with appropriate order for approval.

Information Technology

6. First reading; Authorized Transfer Salary - Systems Administrator

Aron Gish said he is requesting to transfer current employee Connie Chamberlain from a supervisory position in Information Technology to a Systems Administrator position with no supervisor responsibility. Connie currently handles all the AS 400 applications and will be taking on more responsibilities and the transfer exceeds the mid point at 110% but will not exceed the salary of the other Systems Administrator she would be working with.

Commissioner Miller said that Connie has a lot of knowledge and she would hate to lose her so she would support this transfer.

Resource Management

7. First reading; Acceptance of Security Agreement and Letter of Credit for Midway Heights Elementary School Access Improvements

Stan Shawver said he is requesting acceptance by the Commission of a Security Agreement

and Letter of Credit for the Midway Heights Elementary School from the City of Columbia Public Schools. This request is to create a new access to the west of the school, off 12 W. Blvd. In order to permit the developer to disturb land on the development, and to assure the County that the required erosion and sediment control and stormwater management will be completed, the developer must secure the erosion and sediment portion of the project.

Sheriff Department

8. Second reading; Personal Trainer Services Agreement (1st reading 5-2-13)
