2. First reading; RFP Award Recommendation 12-04APR13 - Bond Counsel Services

Melinda Bobbitt read the following memo:

The Request for Proposal for 12-04APR13 – Bond Counsel Services for the Boone County Treasurer closed on April 4, 2013. Seven proposal responses were received.

The evaluation committee consisted of the following:

CJ Dykhouse, Legal Counsel

June Pitchford, Boone County Auditor
Bob Wagner, Boone Hospital Board member

The evaluation committee recommends award to Gilmore & Bell, a Professional Corporation of Kansas City, Missouri per their attached Evaluation Report.

This contract will operate similarly to a term and supply contract in that the scope of services and terms of payment are specified in the contract, but payment is only required when the services are actually used (i.e., bonds are issued).

Nicole Galloway said that they received great proposals and the team was excellent in evaluating the proposals. Gilmore & Bell and Kutak Rock, LLP were shortlisted and invited for interviews. Gilmore & Bell had the experience the County was looking for as well as the previous relationship we had with them. They deal with the type of issues we have on a regular basis. They have a new attorney that has worked with C.J. in the past on Chapter 100 issues. They also provided the most competitive pricing while working with the mid bonds which we issue on a regular basis. They also have Health Revenue Bond experience.

Commissioner Atwill asked if Ms. Galloway knows of any bonding on the calendar for this year.

Ms. Galloway said there are none. Also, what the proposal does is formalize the relationship and services that our bond council will provide to us. There is a conflict of interest section inserted where G & B will make disclosures to the Treasurer and County Counselor on an annual basis. G & B is also open to a post issuance evaluation process with us and our financial advisor. They deal exclusively with Municipal Bonds and have never had a claim to pay out. If a client said they need higher coverage, they would look into that as well.

Commissioner Atwill asked if the working agreement or Term & Supply contract has timeline requirements to provide us with information before we had to sign it.

Ms. Galloway said that we discussed that with them and it is also in our Debt Management Policy. There is a timeline that dictates all of those action items with discussion between the Financial Advisor, Bond Council and the County.

Commissioner Atwill asked who the current Financial Advisor is.

Ms. Galloway said it is Piper-Jeffrey, but there will be a RFP issued to look at different alternatives for a Financial Advisor.

There were no further comments or questions.

4. First reading; Release of Security Deposit for Whispering Meadows

5. First reading; Change Order No. 1 Wade School Rd. & Akeman Bridge Rd. Asphalt Overlay contract overrun

Dan Haid said that like all overruns, more was spent than the estimate. The estimates are based on square yards of the road times the thickness of the pavement. Any variation to the existing features that are on paper can cause a difference from the estimate. In doing the calculations, over the whole project, there was ¼" asphalt. It was also decided to do some approaches to intersections to other roads that were not calculated in the original estimate. It was all necessary work and there was no waste.
