The meeting was called to order at 1:31 p.m.

County Clerk

1. Public Hearing; 2013 Boone County Tax Rates

Commissioner Atwill opened the 2013 Boone County Tax Rates agenda item for Public Hearing and asked if there is anyone present that would like to speak on this issue. There were no speakers and Commissioner Atwill closed the Public Hearing.

2. 1st & 2nd reading; 2013 Boone County Tax Rates

County Clerk Wendy Noren said that the proposal before you will only be a first reading today as several of the rates submitted by the political subdivisions have not been certified at this time. Just looking at the top portion relating to Boone County and not the various political subdivisions, rates are calculated first by the state for property tax rates formulated under the Hancock Amendment or under statute which are two different formulas. There is the County General Sales Tax passed in 1979 which requires 50% of the sales tax revenue

used to roll back property taxes. The need to get \$6.4 million less in property tax is calculated to produce the County levies. Those levies did not change from last year and are 12 cents for General Revenue, 5 cents for Common Road and Bridge and a little more than 11 cents for Group Homes.

Commissioner Miller noted that since the rates are the same as last year, that is a good thing and the property taxes will not be raised.

Ms. Noren said that the other rates displayed are those that have been adopted by the governing bodies of those jurisdictions. They are incorporated into the order to the extent they are in the tax records for collection.

Commissioner Miller read the tax rate totals of each jurisdiction since this is only a first reading. The entire tax rates will be read upon second reading.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Prosecuting Attorney

3. 1st & 2nd reading; Application for continuation of the Violence Against Women Grant

Prosecution Attorney Daniel Knight read the following memo:

I respectfully request your approval to apply for VAWA (Violence Against Women Act)

grant funds for our Domestic Violence Enforcement Unit (DOVE Unit) through the Department of Public Safety.

We have been receiving funds for our DOVE Unit since 1998 and continue to serve over 1000 victims of domestic violence each year.

This grant award is for two years and will be used for the full salary of our Victim Specialist, Mark Koch, and 70% of the salaries of two assistant prosecuting attorneys, Cecily Daller & Jonathan Bertz, all dedicated to serving victims of domestic violence.

There is a 25% matching requirement for this grant and it consists of the cost of the benefits for the Victim Specialist and 30% of the salary of the two assistant prosecutors all currently being paid for by Boone County.

The federal share is \$258,510.72 and the local match is \$87,807.47.

Commissioner Miller noted that there will be no increase in the budget.

There were no further comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby approve the attached grant application request by the Prosecuting Attorney's Office for the Violence Against Women Act for the Domestic Violence Enforcement Unit through the Department of Public Safety.
