6. First reading; Establishing Food Inspection Fees for 2014

Kala Wekenborg said the fee matrix presented to Commission is a result of a work session to determine fees to re-coup costs. After determining the fees, there will be a slight increase from the previous year.

Commissioner Atwill said that this has been a topic of previous discussions.

Commissioners Miller and Thompson said that the increase of \$10 - \$15 is quite reasonable.

Ms. Wekenborg said that there was communication with the Collector's Office to make sure this increase coincides with the billing cycle.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Auditor

7. 1st & 2nd reading; Adoption of the FY2014 Boone County Budget

Commissioner Atwill noted that there has been two public hearings conducted on the proposed budget prior to this request for adoption.

Auditor June Pitchford concurred that two public hearings have been conducted and have complied with all the conditions prior to getting Commission approval on the budget. Also, state law requires that if the Commission authorizes any change to the proposed budget, they must be identified and made available at time of Commission adoption. Attached is a schedule of proposed changes as mandated by state law. One notable change is in the General Fund where there were significant savings realized by making computer hardware purchases in 2013 and this purchase has been removed from the 2014 budget. Lastly, there is a reference to the County Adjustment Policy which will be presented to Commission in the next several weeks.

Commissioner Atwill said this has been reviewed numerous times and the Commissioners thank the Auditor's Office for a job well done.

Commissioner Miller moved on this day, the County Commission of the County of Boone does hereby adopt the Boone County operating budget for fiscal year 2014. The adopted budget shall consist of all appropriations included in the Proposed Budget submitted to the County Commission by the County Auditor, subject to the adjustments shown in the attached Schedule of Changes to the Proposed Budget.

Total appropriations are set forth by line item and are summarized as follows:

- 1) by category of expenditure (i.e., class 1, class 2, etc up to and including class 9.);
- 2) by office, department or spending agency; and,
- 3) by fund.

Appropriations may not be exceeded at the class level for a given office, department, or spending agency without approval pursuant to the County's Budget Adjustment Policy. Total appropriations for each fund are set forth in the individual Fund Statements and are published in the County's FY 2014 Budget. The Proposed Budget submitted by the County Auditor, which is hereby incorporated into this appropriation order by reference, contains detailed documentation and descriptions for each line-item account within each category of expenditure. Appropriations shall be expended only for the purposes that are within the intent of the category in which they are included.

The County Commission approves all employee positions included in the Proposed Budget, adjusted for Commission changes noted in the attached schedule, together with the specified budgeted hours, range, and benefit status for each position.

The County Commission approves appropriations for the specific fixed assets identified in the various fixed asset appropriation accounts and authorizes procurement of the same in accordance with the Budget Adjustment Policy and the County Purchasing Policy adopted by the County Commission.

The County Commission authorizes the County Auditor to re-appropriate unspent FY 2013 grant funds (which may be carried forward into FY 2014 according to the terms of the grant award) upon determination that a remaining balance of the grant award is available for rebudgeting.

10. Second reading; Request to hire a second full-time employee into position #146, Maintenance Worker II (1st reading 12-17-13)

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby authorize Chet Dunn, Road Maintenance Operations Manager, to over-hire into position #146, Maintenance Worker II, and move Caleb O'Keef into said position taking effect December 23, 2013 and continuing until June 30, 2014. The additional cost will be covered from budgetary savings.

11. 1st & 2nd reading; Closure of Breedlove Dr. during inclement winter weather

Chet Dunn said Public Works has had an issue with this road for many years. The steep hill is very dangerous and when it snows, anyone trying to go down the hill will eventually lose control. Recently, we had a motor grader slide down the hill and almost ended up in the creek, a forty foot fall. No one lives in the affected area where we are proposing the closure

during inclement weather. The only use is as a short cut. People not used to this and going there for the first time have no idea of the dangers involved during bad weather.

Commissioner Thompson said that there are other, safer ways to travel in the area. This is not the only route.

Commissioner Miller asked if the hill can be removed.

Mr. Dunn said not realistically, as a bridge about 2,000 feet would need to be constructed.

Commissioner Atwill asked if there has been any consideration on a permanent closure and who is affected by this.

Mr. Dunn said that has been considered and the only affect on a permanent closure is travel time. There are no access points for residents.

Commissioner Miller said that the alternate route using Thomas Hill Road and Tucker School Road does not take up much travel time. It needs to be kept open beyond Thomas Hill Road because of the subdivision.

Mr. Dunn said there is the subdivision off by Fiddle Creek.

Commissioner Atwill said that this could be considered later if conditions merit this decision.

Mr. Dunn said Public Works plans on putting up three different signs at different location points to alert drivers of the possible closure of the roadway. The only time to go down there would be if there was an injury accident. The signage approach is better because any permanent barricades put up will eventually be destroyed.

Commissioner Miller asked Mr. Dunn to check with County Counsel to make sure the language on the signs to be posted will cover County liability before they are erected.

Mr. Dunn said he would do that.

There were no further comments or questions.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby authorize, in the interest of public safety, the temporary closure of Breedlove Drive due to the hazardous terrain and dangerous conditions created by winter weather. The closure would take place beginning at Fiddle Creek Lane and continue approximately 3,000 feet to the east. This section of Breedlove Drive would only be closed during inclement winter weather.

Commissioner Thompson seconded the motion.
