Commissioner Atwill said we have signed the order and a member of the Health Department will work with you and if you can accomplish what needs to be done, that person will assist you. If you can't do it, they will be authorized to proceed independently to resolve the abatement.

Mrs. O'Keefe said she has fallen three times in the past 10 days and she is not as strong as she used to be. She has been working on this, but needs more time.

Commissioner Atwill said we all wish you the best and you will be contacted by a County employee who will assist to the limit of their ability and the limit of the county's authority. We hope that will work out to your advantage.

Commissioner Thompson asked if she has ever contacted Services for Independent Living (SIL) as they might be very helpful in this instance.

Mrs. O'Keefe says she has problems with fatigue and then it goes away and she gets things done.

Commissioner Atwill said he has just contacted the Health Department and they are sending someone over right now and asked Mrs. O'Keefe to please take a seat and they will be here for her to talk with them.

#### 7. First reading; Approval of Automated PAF Process Protocol

Jenna Redel said this request is to issue an order that pre-authorizes the Treasurer and Auditor to appoint staff as authorized for their offices in the annual appropriation order in accordance with the specific positions approved in the annual budget and the established hiring policies of the county.

There are two statutes, 54.230 RSMo and 55.100 RSMo, both which require the County Commission approval for appointments to these two offices. We traditionally do this through the budget process and we are trying to move to an automated PAF system and the mechanics require we have an order in place to do that.
