- C. J. Dykhouse said this is a new three-year Collective Bargaining Agreement with our Public Works employees. This is the culmination of several months of work. On the shop steward side, the employees were represented by Price Nichols, Tony Crocker and Darren Evans. On the management side, the representatives were myself, Jenna Redel, Greg Edington and Jane Telander. We had good, productive, good faith bargaining sessions.

In a quick summary, some of the changes for this new agreement are:

- Adjustments to the tool allowance
- Timing adjustments on uniform reimbursement
- Technical adjustments to recognize the adoption of the 2017 Pay Plan
- Two reporting locations with the addition of the Public Works North Facility
- Adjustments on how merit pay is distributed to the employees
- Adjustments to the Progressive Discipline Policy
- Sick leave adjustments pertaining to overtime calculations

This represents a good compromise of interests and takes us through 2019.

Commissioner Atwill said we recognize that this is a lot of work and appreciate all those involved in the process.

Commissioner Parry noted that the merit pay is distributed into a pool and the workers divide it amongst themselves.

Mr. Dykhouse said that is how it works, but is not a change to this agreement. The change refers to how they will distribute based on time served and address wage compression.
