# 2. 1st & 2nd reading; Annual Compliance Report from EAG Laboratories, a/k/a ABC Laboratories

Andy Housley said he is the Vice President and World Wide Corporate Comptroller for EAG Laboratories, which is the parent company for ABC Laboratories here in Columbia. We are happy to report that as of March 31, 2017, we had 372 full time employees at ABC Laboratories, which is significantly over the Chapter 100 performance base of 224.

EAG continues to invest locally and, within the last year, we created a shared service center and relocated executives to Columbia and centralized our Accounts Payable, Credit & Collection, Payroll as well as our Accounting functions here in Columbia for our world-wide operations, not just for ABC.

We look forward to continuing to expand and grow in Columbia and, just last month, we had 83 executives here attending our world-wide Life Sciences meeting.

Commissioner Parry asked if they are having any trouble hiring certain types of positions.

Mr. Housley said not really. There are currently a lot of open requisitions, especially on the financial side as we are hiring more people and increasing that piece of the business. We are not just looking in Columbia, but more Midwest, such as St. Louis and Kansas City and relocating them here.

Commissioner Atwill asked if the direction of the business has changed at all.

Mr. Housley said there has been phenomenal growth in the pharmaceutical area, especially in testing. Here, at this facility; it is a mix of environmental sciences and pharmaceuticals. We have really seen great growth in pharma and will continue to expand and invest in that.

Commissioner Parry asked what the split is, in terms of employees, at the old campus off I-70 and the one on Discovery Ridge.

Mr. Housley said it is hard to determine since we have employees go back and forth. A guess would be around the 60/40 or 70/30 range.
