Purchasing

1. First reading; Bid Award 17-12APR17 - 2017 Mill & Overlay Term and Supply

Phil Fichter read the following memo:

6. First reading; Contract Amendment No. 1 – Food Service Contract between Boone County and CBM Managed Services

Captain German said this is for the food services contract between Boone County and CBM. As part of the contract, they are allowed to look at the Consumer Price Index, and make adjustments off that index. It is at 2.3% and the contract will be adjusted accordingly and renewed.

7. First reading; K-9 Maintenance Training Agreement between Boone County Sheriff's Department and Boonville Police Department

Captain German said this will be an extension. They were our original customer on the K-9 Training Program. They purchased a dog last year and received a year of maintenance training for that and now they wish to continue the agreement for another three years.

There were no comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. First reading; K-9 Maintenance Training Agreement between Boone County Sheriff's Department and Callaway County Sheriff's Department

Captain German said this is Callaway County's first dog and they have requested dog and handler training.

Public Works

9. First reading; Ipad Mini Purchases

Greg Edington said the Public Works Maintenance Operations department budgeted \$1,500 in account 2040-91301, new computer hardware, for the purchase of two Ipads for the new Cartegraph software. The items were budgeted prior to developing operations to fully utilize the new version. Throughout the Cartegraph implementation process, we discovered that Ipad Minis are as functional as the bigger version at half the cost, approximately \$500 each. There is also a need to purchase additional units, in addition to the two that are budgeted for one Supervisor and two crew leaders. The added units will enable the users to enter their daily work directly into the system and save the step of filling out a form and having someone else enter the data.

The department desires to purchase three units from the original appropriation and two additional units with cost savings in class 9. After speaking to the Auditor's office, this request does not need a budget revision, but it does need your approval. I am not sure if this will have to be an agenda item.

There is approximately \$172,000 in cost savings in class 9 in this fiscal year to account for the extra \$1,000 that is requested. There should be five units in total.

10. 1st & 2nd reading; Revision to P-Card Policy

Tom Darrough said there has been a significant increase in the use of the P-Card, month-to-month. We are trying to make sure we have checks and balances in place that are consistent with Purchasing policies of the county.

The impetus was the problems with the billing from Dish Network. This change allows us to put recurring charges on the P-Card which has been prohibited prior to this new change. We will not be circumventing any Purchasing policies.

Commissioner Atwill noted that the attachments referenced what has been removed. He asked if there will be another version detailing what has been added.

Mr. Darrough said nothing will be added, this just removes the restrictions as noted in Section VII.

There were no further comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby adopt the attached P-Card Policy revision.

Said revision relates to Section VII – Prohibited Use of Purchasing Cards; removing the following:

- Purchase of lease or rentals that require signed agreements and/or extend over a period of time.
- Purchases pursuant to any Maintenance/Service/Licensing Agreements which requires a contract signature.
