Contract 129-123116SS – Software License and Services for Computer Aided Dispatch Systems (CAD) was approved by commission for award to Sungard Public Sector LLC of Lake Mary, Florida on March 24, 2016, commission order 148-2016.

This amendment assigns the contract from Sungard Public Sector LLC to Ramundsen Superior Holding, LLC, d/b/a Superion, LLC.

Invoices will be paid from departments 1170 – Information Technology, 1123 – Emergency & Contingency, accounts 91302 – Computer Software, 71101 – Professional Services, 91301 – Emergency & Contingency, 37210 – Training/Schools, 70050 – Software Service Contract. A Budget Amendment is included for this purchase.

Information Technology

5. First reading; Budget Amendment for Small Law Enforcement Agencies RMS/JMS
Project

Aron Gish said this budget amendment is based on the previous contract just read by purchasing. It is for the small law enforcement agencies of Ashland, Centralia, Hallsville, and Sturgeon to purchase a Records Management System license and a Jail Management System license. This will get them on the same computer-wide system as is Boone County, City of Columbia, and the University of Missouri. This will enable them to communicate to the same back-end system.

Commissioner Parry confirmed that all four communities are on board.

Mr. Gish said they are. Once this is approved, we will distribute contracts and invoices. They all have submitted letters of commitment to the project.

Commissioner Thompson said this has been a collaborative effort by many departments.

Mr. Gish said that Sheriff Carey and Captain German have been the anchors on this project. After five years, the small communities will have paid back any cost associated with this and then pay an annual maintenance fee.

Commissioner Thompson said this is going to be a great benefit to our communities to have one Records Management System where all these agencies can communicate effectively.
