3. 1st & 2nd reading; Accept certification of the election held on November 7, 2017 regarding Proposition U

Taylor Burks said under state statute, we have 14 days to have a Board of Verification sample precincts, do a hand count, audit, and review. If all goes well, which it did, we certify the election results.

The turnout was at 11.12%. Under the Show it to Vote, the state's new voter ID law, we had four ballots cast provisionally because the voter did not have ID. After the election, the Board of Verification reviewed the ballots and certified all four.

There were six other provisional ballots for people who were at the wrong polling location. Four of the six were certified, the other two were rejected as the voters were not registered in Boone County. We ask that the Commission accept the certification of the election.

There were no comments or questions.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby accept the attached certification of election from the County Clerk and Election Authority for Boone County, Missouri for the election held on the 7<sup>th</sup> day of November, 2017 regarding Proposition U to impose a local use tax on out-of-state purchases at the same rate as the total local sales tax rate, currently one and three quarters percent (1.75%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action.
