The meeting was called to order at 1:30 p.m.

Collector

1. First reading; Tax Collection Agreement with the City of Rocheport and Boone County

Brian McCollum stated this is the same standard format that they have been presenting for the last couple of months as they work through all of these. Once Rocheport has been approved, that just leaves City of Columbia, and theirs is scheduled for a second reading next week. So, that should wrap up all the updated collection agreements that we have with municipalities.

There were no comments or questions from the Commission.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Facilities Maintenance/Sheriff's Department

2. First reading; Budget Amendment: Painting Project Sheriff Administration & Jail

Gary German explained that this would be specifically the control rooms where the Control Officers work and the booking room. This kind of goes along with the countertop project they had, and then the carpet for the administration building as well. We worked with Facilities Maintenance and although they did have money budgeted for it, they didn't feel they have enough staff to dedicate to the project. So, we put the painting out to bid and came out at \$48,748 and then the \$4,875 would be contingency funds. Part of the issue is going to be the timing in making sure that we move offices and immediately get in there to paint and then follow that up immediately with getting the carpet put in the building. This will just make a little bit of a juggling act, but we can do it.

Commissioner Parry wanted to confirm that it was painting the medical office, manager's office, psychologist's office, A-Pod Control, B-Pod Control, C-Pod Control, and the booking room.

Gary German said yes. The medical offices are also getting new flooring.

Commissioner Atwill wondered if paint fumes would be an issue for the inmates.

Gary German explained that they had discussed that and they will be using some lowemission paint for that and there will be positive airflow equipment they will be able to set up in spots that might need it and that will help vent that out.

There were no more comments or questions from the Commission.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with

3. First & Second reading; Joint Communication's Request for An Extended Training Period for Position 844, ETC Trainee

Jenna Redel explained that there is currently a standing Commission order that allows for a two week overlap period for having two employees in the same position for training purposes. In this instance, Joint Communications is asking for an extension on that training period as they have just now filled all of their vacant positions and almost immediately after filling that last position, they got a resignation notice. That employee intends to have their last day be September 1st. They have a training class that starts July 30th. So, they are asking for the extension in order to bring the person replacing the employee leaving in September into the training class that starts on July 30th.

Commissioner Parry asked if it was only a 30-day extension.

Jenna Redel said it is actually only a two-week extension.

Commissioner Parry moved on this day the County Commission of the County of Boone does hereby authorize, pursuant to Commission Order 147-2005, an extended training period for position 844, Emergency Telecommunicator Trainee, from July 30, 2018 through September 1, 2018. BCJC has received a resignation notice from the current employee in this position, effective September 1, 2018. A training class of new ETC Trainees is already scheduled to begin on July 30, 2018 and allowing position 844's replacement to start with this class will save training costs and minimize downtime in the position.
