# **Boone County Regional Sewer District**

 First & Second Reading; Consider applying for a Missouri Department of Natural Resources (MDNR) loan for the Bolli Road Sanitary Sewer Neighborhood Improvement District (NID)

Tom Ratermann explained that Bolli Road serves ten homes out off of Highway 40. The loan application is for \$319,000. We have also completed an income survey out there and these folks might qualify for a grant. Current sewer district rates are \$60 per month and it will go up to \$62 per month next year contingent upon board approval. It lays out a schedule of trying to get this built in 2020. I checked with the Boone County Treasurer about applying for this loan and he agrees with trying to acquire these loans as they are low interest.

Commissioner Atwill wanted to clarify that it didn't require any matching funds from

County taxpayers.

Tom Ratermann said no, it does not. The way neighborhood improvement districts work is when the projects are finished, the County Auditor certifies final costs, the County Clerk makes a special assessment against the properties, and then the County Collector collects those special assessments in the same manner as real estate taxes.

There were no comments or questions from the Commission.

Commissioner Parry moved on this day the County Commission of the County of Boone does hereby approve the application for a Missouri Department of Natural Resources (MDNR) loan for the Bolli Road Sanitary Sewer Neighborhood Improvement District (NID).

We keep it all the full amount since they are using the entire site to fill at this time, which is \$42,924.42. They extended the bond on their end before it was expired.

## Purchasing

9. Second Reading; Cooperative Contract: 180501 – Networking Equipment, Software, and Services (1st read 11-8-18)

Director of Information Technology Aron Gish was present to speak on this item as it is his department that was requesting to use the Cooperative Contract.

Aron Gish explained that this was a standard competitively bid contract that we keep on file to use as needed.

Commissioner Atwill asked if it was a term and supply contract.

Aron Gish said yes, basically. It is for equipment that has been competitively bid for the TIPS. This contract differs from a term and supply in that the consortium of states go out for bid and get a competitive bid back in their award and then we piggyback on those. That is what this contract would be. So, for example, this one would have Sisco networking equipment that we use for our wireless here, it would have servers and switches. Then we would go out when we need that equipment and look at this contract since it is on file already and we would look at another contract that is held with CDW and compare prices on those and if they are under retail, then we would consider that a competitive contract and we would buy the lowest we have with contracts available. We would do this instead of going out to bid or requesting an RFP for every purchase. When I put in my request every year to have administrative authority to purchase, it is off of these contracts.

There were no more comments or questions from Commission.

Commissioner Thompson moved on this day the County Commission of the County of Boone does hereby approve the utilization of the TIPS cooperative term and supply contract 180501 with Mobile Wireless LLC of Plano, Texas to provide Networking Equipment, Software, and Services on an as needed basis.

The terms of the cooperative contract are stipulated in the attached Purchase Agreement. It is further ordered the Presiding Commissioner is hereby authorized to sign said Purchase Agreement.

#### **Sheriff's Department**

- 10. First Reading; K-9 Basic Training Contracts with the following:

Gary German explained with Callaway County, they did the basic training on their dog and they wanted to follow up with us to do the ongoing maintenance training. It is \$1,800 and renewable over a three-year period. The one with Morgan County was a re-train contract. It was a deal where the dog was already doing what it needed to be doing and we just needed to try and get a handler that was up to speed with that. Normally those contracts are \$3,600, but because the dog had already been trained we felt we could train a little quicker. So, that is why this one is \$1,800 because it was a review of the class.

There were no comments or questions from the Commission.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to

schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

#### 11. First Reading; RMS/JMS Cooperative Agreements with the following:

Gary German explained this is a way for us to help out our smaller municipalities and help get them up to the same level as everyone else. We want to be able to get everyone on the same system and move forward. This will also help to break up the cost to the smaller entities, so they don't have to do endure as much of that during the initial stage of it. It breaks it up over five years for the cost and then the maintenance is also added on to the system and they are responsible for that. Every year they have to pay maintenance on it. The total outlay is \$69,541 for being able to buy into this system and then the maintenance on it is \$5,048.

Commissioner Parry asked if we were missing anyone for this.

Aron Gish said no. These are the four agencies we reached out to and they all agreed to participate. This is memorializing this process, it is already active. The County Commission signed off on the agreement to move forward with this over a year ago. This is us receiving all the contracts signed back from the other agencies and finalizing it. We have received a single payment from each agency already. They will go live approximately the same time the Boone County Sheriff's Department does which is estimated to be December or January. Commissioner Atwill asked if the County funding comes from the Joint Communications Emergency Management tax.

Aron Gish said no, it does not. This is basically a five-year loan that we agree upon that is coming out of general revenue and then going back into general revenue. This is all RMS/JMS related. It is not CAB related.

There were no more comments or questions from the Commission.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
