Gary German said these are the standard training agreements with the ones for Callaway and Cooper counties being the basic training, doing the dual-purpose dog training. The only thing of note for the Cooper County contract: they had maintenance training through the Boone County Sheriff's Department and their handler left so they had to select a different handler. They had pre-paid, so they are basically getting credited their advance payment, so it is a reduced fee. The dog still has service life left, so it is basically a retrain with a new handler. The contract with Lebanon is a standard maintenance training.

Commissioner Parry asked what the service life is for one of the dogs.

German said, generally speaking, 8 to 10 years. They did have one that gave almost 12 years before.

Commissioner Parry said Congresswoman Vicky Hartzler was in Rocheport this morning. Sandbagging continues down there. There were probably about 40 volunteers there this morning sandbagging. They basically had secured everything around the trail. The water continues to rise.

Commissioner Atwill said he spoke with the Mayor of Rocheport this morning. He said he was very satisfied with all the help they have received with sandbagging and such. The Mayor was especially impressed with Emergency Management Operations Director, Tom Hurley.


