Commissioner Parry asked how this compares to the current rates.

Bobbitt said the fee is 7 percent right now.

Commissioner Thompson asked more about the details of the services that are offered.

Christy Blakemore said a big factor when looking at this was all the services offered because the Circuit Clerk does have to have reports and they have to be able to tie the sale on a card to a specific case. In speaking with MSB, it seems that they will get all the reports that the County currently gets and maybe some additional ones. Another big factor for this is all the different departments as there are sales done at the jail, in the actual Sheriff's Department, and multiple offices in the courthouse. All those monies go to different accounts and MSB was able to do that. No abilities will be lost going to this new company; in fact, more might be available, for instance the texting. That is a function that could very likely be implemented down the road.

Commissioner Thompson asked if they were able to ascertain about other jurisdictions' satisfaction with this vendor.

Bobbitt said they did do reference checks and they received very favorable references, particularly on customer service.

Blakemore said another plus would be that they will now have a machine on the outside of

the window so employees will not be having to handle cards, which they currently do. Also, speaking on customer service, there is going to be a set group of four people that will be assigned to the County so they will always be speaking with the same people whenever issues arise that would warrant calling the company. That will be a very big plus to have the same people all the time who will know who the County is and what accounts there are. St. Louis, Missouri is where the County's contact people will be located.

3. First Reading; Purchase Agreement: 65-123119C - Timeclock Plus Perpetual License Agreement

Melinda Bobbitt read the following memo:

Attached for signature is contract # 65-123119C - Timeclock Plus Perpetual License Agreement. Time keeping with Timeclock Plus was included in the Superion contract previously approved in Commission, Commission Order # 308-2019. Timeclock Plus, LLC is partnered with Superion (Central Square Technology) as the third-party tool application that collects time reporting. This software will replace payroll requisitions and timesheets. County staff will enter time into Timeclock Plus which will advance for supervisor approval through the system. Once approved this information will push into the payroll module.

Cost of Timeclock Plus that includes maintenance was included in the Superion contract for \$51,720. All the funds have been encumbered with a purchase order issued to Superion from department 1170 - Information Technology, account

92302 - Replacement Computer Software.

## 5. First Reading; Surplus Disposal: Computer & Peripheral Surplus Disposal

Melinda Bobbitt read the following memo:

The Purchasing Department requests permission to dispose of the following list of surplus PC peripheral equipment and unworking air conditioners through MRC Recycling Center. MRC Recycling will pick up our surplus at no charge. They are a State of Missouri, DNR Level Four recycling center. No computer items are land-filled. Purchasing will obtain a Certificate of Destruction, and we will let them know that we want everything recycled, not reused so nothing ends up in the landfill.

Prior to computer surplus coming to Purchasing for disposal, Information Technology has removed the hard drives for destruction by their department. Their procedure for PC disposal is:

Once all the data is copied or recovered for the user, IT removes the hard drive and memory from the PC. The memory is held to be used for upgrading other PCs at the county that can benefit. IT sometimes removes parts that can be used as spare if the model is current enough. (ie Power Supplies, Video Cards, etc.) The hard drive is held for a minimum of 30 days in case a user identifies something is missing. After 30 days IT may reuse the hard drive in other county PCs if there are failures. If a hard drive goes unused or fails and IT needs to physically dispose of it, they drill a 5/8" hole through the drive and the data platters. Once IT has a collection of "drilled" drives, they deliver them to PC recycling vendor MRC Recycling Center.

MRC Recycling Center certifies that they have picked up the following items and

that all items will be recycled, not reused, so nothing ends up in the landfill,

Peggy Placier was present to address the Commission about the credit card processing fees.

Stephens read a prepared statement to the Commission. That statement is included at the end of these minutes.

Dee Dokken was present to address the Commission about the Perche Ridge Development.

Dokken said she represents the Sierra Club and she wanted to emphasis that this is not just neighbors not wanting development in their area, this is a city-wide and county-wide concern. At the last City Council meeting, three out of the five attending council people endorsed a tabling or moratorium on development in this area, and hopefully a letter from the City is on its way to the County. She is a little frustrated. It seems the City seems to think they decided to do this months ago, but she is not sure the same requirement of an official statement was necessary when the other plans were done. As far as she knows, the City thinks that letter from Tim Teddy was them saying they want to do a West Area Plan. Their idea is if the two groups get together and decide on the extent of the plan and a timetable, then something may come to both bodies for a final approval. Meanwhile, it seems like unnecessary foot dragging. The City Council unanimously said they want their Planning Department to pursue a West Area Plan.

Commissioner Parry asked if the Council actually voted on this,

Dokken said they did not actually vote. This was at the end of a meeting during Council comments and they all agreed on it.

Commissioner Parry said it seemed to him that there was written communication that the City Council had not approved anything, but they wanted to invite the County to participate. Dokken said she thinks the way the City Planning Department was thinking is that they would start the process in conjunction with County and then come up with proposal.

Commissioner Thompson said County had a meeting with City about halfway through her first term, and at that point, the County was told the City was not interested in a West Area Plan and that would have been about three years ago. So that is the County's problem, the last official word received from the City was no. It is good that there is movement now and it is excellent that everyone has been so present in expressing their concerns because it has brought it to the foreground. It is helpful that it is not another government group expressing the need, rather that the people in the community are.

Commissioner Parry said there are mixed signals being sent from the City. The City could have denied the sewer access, which would have stopped the whole thing.

Dokken said the City was afraid that the County would okay it anyway and then there would be pollution.

Commissioner Thompson said, honestly, they kicked the can down the road into the County's yard

Being in jail and coming to court in stripes and shackles may affect the outcome at trial. Being in jail also means loss of freedom, time, contact, and/or income.

#### Cash bail targets those least able to defend themselves and costs the community as a whole:

- Many people cannot afford even a relatively low amount of bail. Some take out loans at high interest rates to pay bail or bond.
- If someone pays a fee to a bail bond agent (10% of bail), that fee never comes back.
- Incarceration and bail far disproportionately affect African Americans in Columbia.
- It costs the whole community to keep someone in jail. There are alternatives.

#### The RMF Community Bail Fund group has worked hard to:

- Research the bail system and incarceration in the United States, Missouri, and Boone County.
- Study how other communities address bail. We are a member of the National Bail Fund Network.
- Gather donations to support our work.

#### The RMF Community Bail Fund criteria for service are:

- \$2000 or less total cash bail. We do not pay bail bonds companies.
- Nonviolent charges.
- Boone County residents facing Boone County or Columbia municipal charges.

In the long run, RMF wants to see an end to cash bail. We advocate for fairer and cheaper alternatives to bail. We could use jail funds to provide housing, health care, job training, and treatment.

Re: Features in an ethical credit card contract for jail services

**Date: October 24, 2019** 

The RMF Community Bail Fund has not used a credit card since our first bail. This was when we found out the very high fees charged by CourtMoney. Our funds come from local donors who want us to spend them on bail, not credit card fees. Since that first experience we use a time-consuming process of withdrawing cash to purchase low cost money orders. We need that paper trail, and the jail provides no receipts for cash transactions. We took our concerns to the Criminal Justice Administration Coordinating Committee, where none of the explanations provided for using CourtMoney seemed to account for the high fees.

We want to emphasize that the credit card services at the jail affect anyone who wants to bail someone out, not just the bail fund. While we put our volunteers through this time-consuming process, most people do not want to carry quantities of cash or to purchase money orders, which are not always available for large denominations. They see online that the jail accepts credit cards. By the time they drive to the jail and find out about the fee, they just go ahead and pay it. Often these are people who needed that fee money.

A credit or debit card transaction could be good for everyone if we could stop being overcharged. In the new contract, we should push for:

- 1) Lowest fees.
- 2) Acceptance of most credit/debit cards
- 3) No "piecemealing" of charges, e.g., into \$20 increments, each with a separate fee. This applies to adding money to an inmate's account
- 4) Available 24-7-365
- 5) Payable at the courthouse and from home, online. This would preclude our volunteers from having to deal with money at all.

We urge you. Please do not renew with CourtMoney. There must be a better alternative.

STATEMENT TO BOONE COUNTY COMMISSION, OCTOBER 24, 2019,
BY JANA STEPHENS. FOR THE PERCHE HILLS NEIGHBOORHOOD COALITION

My name is Jana Stephens. I reside at 6401 West Druid Lane. I am here today representing the 73-member, 35-household Perche Hills Neighborhood Coalition. As you know, we strongly support a City-County West Area Plan to guide development in Boone County west of Perche Creek, which happens to be the area of the county we reside in. I want to emphasize that we do not oppose further housing development in the area. Rather, we are in strong support of a deliberate, considered plan for development in which all stake-holders have had input, as an alternative to a process based on a decades-old master plan for development that projected its then current needs long into the future.

As you know, we are particularly concerned with the pending approval of Fred Overton's Perche Ridge Subdivision, with its encroachment on a major floodplain; where flooding takes place often enough that the Boone County Road Department sees fit to have permanently stationed large road barricades at the side of the road ready to be deployed; serious enough flooding as to prevent first responders from getting through, forcing them to take a longer, alternative route around the flood.

We are very concerned that any building up of the seven lots of Mr. Overton's subdivision that lie within the 100-year flood plain will inevitably cause increased runoff, thereby increasing the severity of flooding on Gillespie Bridge Road. The impact of expected climate changes in coming years should not be underestimated, bringing the potential for more frequent and severe flooding events. One only need consider the extent and prolonged nature of the flooding on the Missouri River this year

to have a sense of what may be in store.

We are concerned with safety issues generated by a significant influx of many additional vehicles that the subdivision would bring. At this particular portion of Gillespie Bridge Road near Coats Lane, already rather hazardous, due to a blind, downhill curve, great care and quick acceleration are necessary when entering Gillespie Bridge Road from Coats Lane. Numerous subdivision vehicles entering Gillespie Bridge Road from the north at Coats Lane below this blind curve will greatly increase the risks.

Again, we are not opposed to development. We are opposed to **this particular** development, and to development that is generated primarily by landowners' desire to develop, rather than a development plan put together by a City-County governmental coalition, in which stakeholders have had their input. Development is inevitable, because population pressures are increasing. But, **please**, let's do it right.

Therefore, we adamantly request that you table final approval of the Overton Plat and suspend all further approval of development in the Gillespie Bridge-Coats Lane corridor pending creation of a joint City-County West Area Plan. Thank you very much!
