11. First Reading; Adoption of a Resolution supporting the Economic Development Administration Grant for the Ranken Technical College project in Southern Boone County

Commissioner Parry said the Commission has been approached to make a gift of \$100,000 to help support the 90/10 grant that is being applied for by the City of Ashland to construct the Ranken Technical College facility. He supports giving this gift to Ashland. It has been noted that the economic recession from COVID-19 is expected to last 3 to 5 years and this is

a wonderful opportunity to support the community.

Commissioner Atwill asked if that amount was available.

Commissioner Parry said there is in the Community Health Fund. This college will be training a lot of CNAs and RNs and the like and that fits in what that fund should be used for. This was reviewed yesterday by Joanne Nelson.

Commissioner Thompson said that she did not think the Community Health Fund was the appropriate place for the money to come from. Doing this could potentially open for other things in the future that aren't appropriate. This request is really economic development and might be better suited to come from the Airport Fund.

Commissioner Atwill asked who had jurisdiction over that fund.

Commissioner Thompson said the Commission does. She also wanted clarification that this would be a gift and not reimbursable. Some of the information she had seen suggested that the other sources donating to this expected to be reimbursed at some point.

Commissioner Parry said it would be a gift and to his knowledge, no one was expecting to be reimbursed. Joanne Nelson has no concerns with this and has guided them during the application process. Nelson felt that all the NA and RN training would definitely be of benefit to the community health wise and fit in with what the Community Health Fund is to be used for.

Commissioner Atwill said that the resolution does not indicate which fund this money will come from and County Counselor CJ Dykhouse is the one that drafted it. He believes this should be supported. The Commission needs to support Ashland. He suggests that the resolution gets adopted as written at the next commission meeting so that Ashland can get this grant as time is of the essence for that. The Commission can further discuss where the funds will come from after it gets approved.
