 First Reading; Contract Amendment Three: 40-27NOV18 for Law Enforcement Uniform Clothing and Boots, Term and Supply for the Boone County Sheriff's Department

Liz Palazzolo read the following memo:

Amendment #3 to contract 40-27NOV18 for Law Enforcement Uniform Clothing and Boots, Term and Supply for the Boone County Sheriff Department that was awarded February 19, 2019 (Commission Order 67-2019) is being amended to add some shirt and boot items the Sheriff's Department requires.

3. Second Reading; Emergency Purchase Agreement: 16-30SEPE – Summer Meals for Kids Program with Harrisburg R-VIII School District (1st read 7-2-20)

Joanne Nelson said she sent the Commissioners a breakdown of school districts and what funds they received as requested by the Commission at the previous meeting.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby award Contract 16-30SEP20E – Summer Meals for Kids Program to Harrisburg R-VIII School District.

Resource Management

4. First Reading; Waste Collection Event Cooperative Cost-Share Agreement: Mid-Missouri Solid Waste Management District

Bill Florea explained that, since 2015, Boone County has worked with the City of Columbia, the University of Missouri Board of Curators, and the Mid-Missouri Solid Waste Management District to do a solid waste collection event once a year. The event is held at the University and people can bring in old electronics, hazardous waste, tires, etc. Last year, the cost exceeded what could be approved without Commission approval, so it is being presented to Commission this year. The cost is split three ways. Last year, the County's share was \$7,500.

Commissioner Atwill expressed concern for the high cost for a one-day event.

Commissioner Thompson said it is a huge event where a lot of people from a lot of different areas come to dispose of items. Essentially, the entities involved in this event are paying for someone else to get the waste taken care of.

Florea said he could provide data on how much material has been collected in the past, etc.

That information is included at the end of these minutes.

5. First Reading; Road & Bridge Improvement/Repair Cooperative Agreements:

- Harrisburg
- Sturgeon

Bill Florea said these are the revenue sharing agreements for road & bridge improvement/repair with Harrisburg and Sturgeon. Harrisburg will be paid \$12,581.54 and Sturgeon will be paid \$37,744.62. This is the second of six years in the cycle.

6. First Reading; Grant Acceptance: BJA FY20 Coronavirus Emergency Supplement Funding Program

Gary German explained this is the grant funding for the Coronavirus emergency funding and should also pay for some of the expenses the Sheriff's Department already incurred to prepare for the COVID-19 response. The amount awarded was \$58,008 and the Sheriff's Department is sitting at about \$9,000 already spent in response thus far. The remainder of the funds are going to go toward additional supplies, sanitizing products, etc.

7. First Reading; Budget Amendment: Establish a budget for funds received for the FY20 Coronavirus Emergency Supplemental Funding Program Grant
