Resource Management

1. First & Second Reading; Request to rename Road: Sims Road to Quiet Life Lane

Ryland Rodes explained there was a request to rename a County-maintained road. Sims Road is located in S34T51NR13W and is recorded in Book 4792, Page 142 and Book 5193, Page 87 of the Boone County Records. It is being requested to change the name to Quiet Life Lane. It would begin on the north side of Blakemore Road, approximately 2,200 feet east of the intersections of Blakemore Road and Oak Grove School Road, running in a north direction for approximately 1,100 feet.

Commissioner Parry asked if people live on the road.

Rodes said, currently, no one lives on the road. It will be developed, but nobody is there right now that a name change will affect. Renaming the road would be helpful for Joint

Communication purposes since there are already two other Sims Roads located in Boone County. One is in the City of Columbia and one is in Centralia.

Commissioner Atwill asked how many homes would be there.

Rodes said he did not know the number, but it is zoned A-2, so it would follow those regulations. The property owners do not want it to be dense.

Commissioner Atwill asked if it was required to give any notice.

Rodes said it is required to give notice of the petition, which was done.

2. First Reading; Bid Award: 28-09JUL20 – Waters Edge Drainage Improvements – Phase II – 2020

Liz Palazzolo read the following memo:

28-09JUL20 – Waters Edge Drainage Improvements – Phase II – 2020 opened on July 9, 2020 with five bids received. Resource Management recommends award by lowest responsive bid to Plan B Development, LLC.

Cost of the contract is \$81,722.00. There will be a 10% contingency of \$8,172.20 added for a Purchase Order total of \$89,894.20, which will be paid from Department 2041 – Infrastructure Preservation and Rehab, Account 71202 – Contractor Costs.

Boone County budgeted amount for this contact is \$130,000.

Commissioner Parry asked if the County has done business with this company before. The bid is very low, and he is curious about the quality of their work.

Palazzolo said she can find out.

3. First Reading; Bid Award: 30-15JUL20 Large Format Printer/Scanner for the Assessor's Office – Acquisition Only

Liz Palazzolo read the following memo:

Purchasing requests approval of the award of contract 30-15JUL20 for a Large Format Printer/Scanner for the Boone County Assessor's Office. Two bids were received in response to the Request for Bid. The evaluation has been conducted by the IT Department in coordination with the Assessor's Office. The award will be made to SumnerOne of Columbia, Missouri for only the acquisition of the printer/scanner. Post-warranty repair service will not be awarded. The printer/scanner purchase includes a one-year warranty.

The contract period will run from August 3, 2020 through August 2, 2021,

Payment will be paid from Department 2010 – Assessment/Account 92301 – Replacement Computer Hardware: \$9,560.00

Commissioner Atwill asked why there was no warranty repair included.

Palazzolo explained that came down to the difference of \$9,560 vs. \$11,250 so that was reevaluated; and a repair plan was also bid separately.

Request for Proposal 20-12JUN20 – Auction Services for Surplus Vehicles and Heavy Equipment closed on July 2, 2020. Two proposal responses were received.

The evaluation committee consisted of the following:

Greg Edington, Road & Bridge Director Gary German, Captain The evaluation committee recommends award to Missouri Auto Auction, Inc. of Columbia, Missouri per the attached Evaluation Report. This is a County-wide term & supply contract through July 31, 2021.

The contract includes transportation and auctioning of Boone County surplus vehicles and equipment.

The contract will extend through July 31, 2021 and has four one-year renewal periods.





- ▶ BNE court getting \$450k in work to the building exterior.





Boone County General Revenue Fund General Fund Overview





Juvenile Justice Center

- ▶ Revenue no change.
 - Certification change and Raise the Age MAY result in an increase but there are too many unknowns.
- ► Expenditures down 7.19% (\$29,069)
 - Reduced personnel based on actual expenses (Part time, vacancies and holiday pay), reduced categories to decrease "padding" in Supplies and Utilities.
 - Class 6 Equip/Maintenance reduced based on history and Facilities Maintenance assisting with cooler/freezer combo.
 - ► Fixed Assets decreased significantly due to budget in 2019 to purchase a tractor for mowing and blading snow/ice; but purchasing a 2nd video conferencing unit.

Juvenile Office

- ► Revenues decreased by 47.47% (\$2,530)
 - Children's Division will not reimburse with their CTS funds for drug testing of parents in Abuse/Neglect cases as their own funding remained available.
- ► Total juvenile budget increased by 15.82% (\$73,142.75)
 - The largest increase was in Class 8 as parent attorney contracts and GAL/COP contract were moved to Juvenile from Jury Services budget.
 - Court Costs/GAL Fees were increased by 2% for Guardians ad Litem/Parent Attorney contracts effective January 1, 2021.

Jury Services and Court Costs

- 2021 This will be changed to just Jury. In budget book: Jury and Court master, Jury Only, Circuit Court (courtroom costs).
- Revenue no change.
 - ▶ \$12,000 total no change anticipated.
- ► Expenditures decreased 44.5% (-\$110,320)
 - Supplies down due to less paper needed with eJuror.
 - Utilities down 11.5% (\$1,650) due to no longer paying for MediaCom (getting 1Gb wireless to be in Circuit Court budget).
 - Contractual Services up 19.8% moved COP contract here from class 8.
 - Miscellaneous Down 78% (\$98k) 4 Parent Attorney contracts moved to Juvenile.
 - Fixed Assets down 92.7% due to prior year purchase.


Circuit Court

- ► Revenue up 1.94% (\$3,295)
 - ▶ Home Detention up 4.81% (\$4,780).
- ► Expenditures down .81% (-\$14,267)
 - ▶ Personnel is \$1.2 million of the \$1.7 million budgeted.
 - ▶ Supplies down 7% for printer supplies and uniforms, but added new things like PPE and increased cost of ammunition.
 - ► Travel/Training up for Court Marshals (instructor training)
 - ▶ Utilities up for new 1 Gig wireless (\$6k annual)***
 - ➤ Contractual services down \$10,565 for changes in electronic monitoring usage. (Adult Court Services)
 - ► Fixed Assets new iPad for on-call and 3 other computers.

Circuit Clerk

- ► Revenues increased 5.08% (\$5,105)
 - ▶ Clerk fee, copy fee, interest, IV-D.
- ► Expenditures decreased 2.46% (\$1,400)
 - ► Supplies down 12.47% (\$4,000).
 - ▶ Utilities up 5% (\$900) (phones).
 - ➤ Service contracts down 2.1% (\$300) maintenance for copiers/printers/microfilm printers.
 - ► Contractual Services up 14.41% (\$1,600) additional bins for shredding & check printing.
 - ► Fixed Assets down 67.35% (\$11,550) Up grading 5 scanners, 1 county computers.


2904 - PropL

- Funds: 3 Treatment Court staff, Mental Health Court, 2 ACS officers, 1 court marshal. For 2021, will be split between Adult Court and Treatment Court.
- ▶ Revenue: no change.
- ► Expenditures down 2.9% (-\$13,068)
 - Miscellaneous down 14.6% (-\$7,420) for testing (number of participants reduced after creating the Co-Occurring Court).
 - ► Fixed assets down because in 2020 we budgeted \$6,500 for a new copier.

2907- Law Enforcement

- ➤ This budget only pays for fiber line costs for the connection to the Juvenile Justice Center. No changes are anticipated in the costs of these services.
- ► Annual cost of \$2,100.00.

- ▶ Revenue Decrease of \$2,020 due to decrease in online FOK fees.
- ► Expenditures Increased \$500
 - ▶ Budgeted to print mediation brochures.
- Anticipated balance end of 2020 for Boone County: \$227,532. Fund continues to grow.

Drug Court Fund

- ▶ January 1, 2020 more than \$393,367.
- ► TCCC grant decreased for FY21 (FY20 award increased \$203,269 that's likely all gone).
- ▶ BJA Equity and Inclusion Grant (OSCA).
- ► Revenue: increased 2.2% (\$2,000)
- ► Expenditures: increased 2.47% (\$5,789)
 - ▶ Supplies up to purchase replacement scanner.
 - ► Travel up to send 3 members to national (\$4,715).
 - ► Keeping classes for testing and treatment as is due to reduced TCCC.

Veterans Court Fund

- ▶ June 1 estimated fund balance -\$58,538.
- ► Revenue: no change.
- ► Expenditures: decreased 17% (-\$11,000)
 - ➤ Contractual Services down 37.5% (-\$9,000). Corrisoft and Reality House.
 - ► Miscellaneous decreased 10.7% (-\$2,500) for testing.

Administration of Justice Fund

- ► Fund balance estimated at the end of 2020: \$86,710. Expenditures exceed revenue in this fund therefore it continues to decrease.
- ► Revenue No change
- ► Expenditures decreased by \$70 (.12%)
 - ▶ Plan to purchase 3 remaining docket boards for courtroom (\$2,950).
 - ► Added \$9,750 to allow for LSR for PD Waitlist representation (\$750 per docket)
 - Added to Class 8, Contingency category, to allow for costs for unforeseen technology needs due to aging technology in 3West and Jury Assembly.


Garnishment Eund Clerk Fee

▶Balance approximately \$57,000. This fund will be used for outsourcing microfilming of records and on boarding for new employees.

- ► Boone County Fund estimate for end of 2020: \$137,384.99
 - ▶ 2020 fund used to pay for maintenance for ground floor video equipment and publication requests, 2 visiting judges notebooks and 10 i-Pads for judges due to Covid.
 - ▶ 2021 fund will be used for maintenance in addition to reupholstering chairs in law library.
 - ► Expenditures are anticipated to be approximately 10% of anticipated revenue in 2020 and 25% of anticipated revenue in 2021, therefore fund continues to grow.
