3. First & Second Reading; Release of Security Deposit: Tompkins Homes & Development, Inc.

4. First Reading; Budget Revision: Move Funds from Training to Class 9 for Purchase of NAS Server

Gary German explained that with trainings being canceled due to COVID, the Sheriff's Department would like to use those funds to pay for a network storage on the network system for the Cyber Crimes Unit. This is a separate network from the County. It has been approved by the Cyber Crimes program to repurpose the training funds for this.

5. First Reading; Budget Amendment: Account for Increase Funds from Trade-In of Ammunition

Gary German explained the Sheriff's Department will be switching the type of gun used. They will be trading in the old ammunition for the new ammunition needed for the new guns. This amendment is to account for the funds received from that. The 9mm ammunition is usually cheaper than the 40 caliber so, long range, it is likely the Sheriff's Department will save money on that.
