Collector

1. First & Second Reading; 2020 Delinquent Tax Certificate Sale Surplus Report

Brian McCollum said this is the report for the 2020 land sale that was held on August 24th. There were eleven properties offered and seven properties sold, for a total surplus amount of \$45,673.62. This will be turned over to the Treasurer to hold for owner redemption or valid lien holder. If not claimed, it will be turned over to the County School Fund within three years.

Emergency Management Operations

2. First & Second Reading; Adopt Updated 2020 Boone County Hazard Mitigation Plan

Chris Kelley said this comes to the Commission as the 2015 Hazard Mitigation Plan is coming to its expiration. Emergency Management has worked with the Mid-Missouri Planning Commission to update the new Plan, including updated action plans in order for Emergency Management and other agencies in Boone County to hopefully apply for mitigation funding through state and federal sources. It is asked that the Commission adopt this Plan with a Resolution so that the RPC can forward it SEMA and FEMA for approval.

Commissioner Atwill wanted clarification that the updated plan has been completed.

Kelley said correct. The RPC has worked with Emergency Management and the other stakeholders from the community to make updates and add action items.

Commissioner Atwill explained that, normally, the Commission would get a copy of the plan. Atwill said he has not seen this and asked if the other Commissioners have.

Commissioner Thompson and Commissioner Parry said they had not seen it.

Commissioner Atwill said he remembers in the past having a presentation of the plan and he did not feel comfortable agreeing to approve this item without having seen the plan.

Commissioner Atwill suggested putting the second reading off until the next Commission meeting pending Commission viewing of the plan.

The second reading of this item was tabled until September 1, 2020.

3. First & Second Reading; Request to Transfer Above the Authorized Transfer Salary: Position 76, Civil Process Deputy, Sheriff's Department

Jenna Redel explained the request is for an hourly rate of \$24.30, which is exactly midpoint for the position and comes to an annual salary of \$50,544. The candidate the Sheriff's Department is looking to transfer into this position is highly qualified, with over 40 years of law enforcement experience in Columbia and Boone County. The person that retired from this position was making a salary relatively close to this, so there will be no internal funding issues.
