Attached for signature is contract # 08-06AUG20C - DocuSign eSignature Enterprise Pro. This is for the license that allows Purchasing to route contracts through DocuSign for electronic signature. There are six seats included. Three will be used by Purchasing and two by Children's Services, who would like to start using DocuSign for electronic signatures. One is used by Information Technology for testing, setup, and to monitor the audit log of DocuSign transactions.
