The meeting was called to order at 1:30 p.m.

Purchasing

1. First Reading: 39-03DEC20 - Inmate Uniforms – Term and Supply

Senior Buyer Liz Palazzolo stated five responses were received: two electronic bids and three electronic "No Bids." The two bids were reviewed and found to meet all RFB requirements. The bid from Charm-Tex, Inc. of Brooklyn, New York was found to be the "lowest and best" bid and is acceptable to the Sheriff's Department for award of contract. The initial contract period will run from January 01, 2021 through December 31, 2021 and includes four (4) one-year renewal options. Payments will be paid from Department 1255 – Corrections/Account 23025 – Resident Supplies: Term and Supply.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. First reading: Rescinding Commission Order 534-2020 and enacting a new Order authorizing disposal of surplus vehicles

Director of Purchasing Melinda Bobbitt asked to rescind Commission Order #534-2020 for Vehicle Surplus Disposal as they have made several changes. The Sheriff Department requests to hold back a Camry that would have been surplused by the Information Technology Department to add to inventory (it was discussed during their 2021 budget preparation). This vehicle will be used for evidence custodians to make MSHP lap trips to the crime labs every other week, staff to take to meetings (i.e. Angela Ayers has MSHP MULES meetings quarterly), training, airport extended parking (once the training starts again), etc. Also, the Information Technology staff person located at the Sheriff Department borrows vehicles to attend meetings or shuttle equipment downtown.

Director Redel stated the Hiring Investigator position is currently vacant. The Sheriff's Department has seen an increase in Sunshine Requests and "body cam" video requests and would like to have a dedicated position for that. By changing this job classification, it will be a budget cost savings of \$9,500.00 per year.

Commissioner Thompson added to the record her thanks to Commissioner Parry for his work while in office. Commissioner Atwill added to the record his thanks to Commissioner Parry for his work while in office. Commissioner Atwill stated Commissioner Parry had been involved in many important items while in Boone County Government and asked that they are placed in the record. Those items are as follows:

- Helped lead the effort for a successful 10-year renewal of the County's road sales tax, which was approved by voters in August 2017. (Sales tax extension approved for 10 year period of 10/1/2018 through 9/30/2028).
- Assisted in the efforts to prevent opioid abuse by approving a Prescription Drug Monitoring Program (PDMP) with other local governments when the state legislature failed to act (Commission Order 212-2017).
- Assisted in the approval of the merger of the Columbia and Boone County Library District into the new merged Columbia and Boone County Library District. (Commission Order 296-2017).
- Helped lead the effort to ensure a positive future for the Central Missouri Events Center (Boone County Fairgrounds) through a transfer to the City of Columbia Parks and Recreation department.
- Supported the County's cooperation with MoDOT, the City of Columbia, and other local governments to ensure the I-70 bridge at Rocheport will be replaced in a way that prevents major back-ups and access issues to Columbia's doctors and hospitals.
- Worked to address issues of residential rental properties in chronic disrepair.
- Assisted in the updating of Boone County's Building Codes.

- Served as the Commission liaison to: Boone County Regional Sewer District; Boone County Senior Citizens Services Corp. (The Bluffs); Convention & Visitor's Bureau; Downtown Leadership Council; University of Missouri Extension Council; Health Trust Committee; and the Regional Economic Development Inc (REDI).
- Assisted in a comprehensive update of the County's Chapter 100 incentive policies.
