1. First Reading: Amendment #1 for Assignment of Contract 46-09NOV16 - Carpet Cleaning Services

Commissioner Thompson read the following memo:

Carpet Cleaning Services is being assigned from American Heritage Carpet and Tile Cleaning to Royal Executive Office Cleaning Services LLC d/b/a American Heritage Carpet Cleaning per the attached amendment.

In addition, the contract is being renewed for another term ending on December 31, 2021. This is a term & supply contract utilized by the Facilities Maintenance department.

2. First Reading: Amendment #1: EC07-14 - 9-1-1 Emergency Notification Software Maintenance for Rave Alert for Public Safety

Contract EC07-14 - 9-1-1 Emergency Notification Software with Maintenance was approved by Commission for award to Rave Mobile Safety on March 22, 2016, Commission order 141-2016.

This amendment adds a five-year term to the contract for annual maintenance renewals for the Rave Alert software. Annual maintenance is \$19,000 and will be paid from department 2708 account 70100. \$20,000.00 was budgeted for 2021.

This Contract was approved by Commission for award to GovDeals, Inc. on November 22, 2016, Commission Order 531-2016.

This amendment adds the option for Liquidity Services Operations LLC d/b/a GovDeals, Inc. to collect all proceeds due the County from the winning bidder and remit the proceeds to the County less the GovDeals, Inc. fee.

This is a term & supply contract that the Purchasing Department utilizes to sell County Surplus on the on-line GovDeals public auction site.

- 1) Extend the contract for one (1) additional year beginning January 1, 2021 and ending on December 31, 2021.
- 2) Revise payment structure to be three (3) installments totaling \$20,100.00 33% of the contract amount within 30 days of the completion and approval of the 2020 year-end report, 33% of the contract amount within 30 days of the completion and approval of the 2021 interim report; and 34% of the contract amount within 30 days of the completion and approval of the 2021 year-end report.
- 3) Except as specifically amended hereunder, all other terms, conditions and provisions of the original agreement shall remain in full force and effect.
