The meeting was called to order at 1:30pm.

Purchasing

1. First Reading: Bid Opening: 11-08APR21 - 2021 Street Reconstruction - Boone Industrial & Interstate Drive

Presiding Commissioner Atwill stated the bids will be opened, the basic information will be read into the record, then the bids will be returned to the Purchasing Department for analysis and determination of whether the bid met the specifications of the proposal.

3. First Reading: NASPO Cooperative Contract: CC190146001 - Professional Grade Tools and Diagnostic Equipment

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve contract 10-11MAR21 – New Haven Road Bridge Replacement which opened on March 11, 2021 with five bids received. Resource Management recommends award by lowest responsive bid to Don Schneider's Excavating Company, Inc.

The cost of the contract is \$376,810.26. There will be a 10% contingency of \$37,681.03 added for a Purchase Order total of \$414,491.29, which will be paid from department 2041 – Infrastructure Preservation and Rehab, account 71202 – Contractor Costs.

Boone County Budgeted amount for this contact is \$423,840.25.

8. First Reading: Budget Amendment for Window and Door Security Project

Senior Accountant Jason Gibson stated this project was originally accrued in the 2019 budget for \$14,000.00 but was delayed due to exploration of further reinforcement options. The budget amount consists of the contract amount of \$29,228.08 and a 3% contingency of \$876.84 for a total project budget of \$30,104.92.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

9. First Reading: PC Workstation and Monitors

Director of IT Aron Gish stated the purpose of this request is to seek approval to purchase new assets, which are an additional PC workstation and monitors (2) for the Sheriff's Office. This PC workstation and monitors will be used by the new position in Records for general office tasks. This need was realized after the recent position changes at the Sheriff's Office. Funds will be from Department 1172 (GF IT Hardware & Software) Account 23820 (Computer Hardware <\$1000) for this purchase of a PC workstation \$959.12, and monitors (2) \$301.02. The Sheriff's Office has prepared a budget revision, moving funds that were savings from department 1228 - class one to 1172-23820.

Total Purchase: \$1,260.14

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

10. First Reading: Purchase New Asset - Laptop

Director of IT Aron Gish stated the purpose of this request is to seek approval to purchase a new asset which is an additional laptop for the Sheriff's Office. This laptop will be used by Captain Brian Leer for general office tasks. Captain Leer is currently utilizing a Panasonic Toughbook from his previous position. Panasonic Toughbooks are in greater demand and are needed for Deputies in the field. We recommend purchasing this laptop and placing the current Toughbook back in rotation for the Sheriff's deputies.

Funds will be from Department 1172 (GF IT Hardware & Software) Account 91301 (Computer Hardware) for this purchase of \$1,299.00. The Sheriff's Office has prepared a budget revision moving funds that were savings from department 1228 - class one to 1172-91301.

Total Purchase: \$1,299.00

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

11. First Reading: Request for Budget Revision – IT Equipment for Sheriff's Office

Director of IT Aron Gish stated this budget revision is to move funds from savings the Sheriff's Office had in their Class I salaries and wages. They are willing to move \$2,560.00 over into their IT budget to pay for the aforementioned IT equipment.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
