# 1. Proclamation Recognizing the 70th Anniversary of Hallsville Go-Getters 4-H

Commissioner Thompson stated Mrs. Elaine George, the "Godmother of 4-H" in Hallsville, along with 4-H in much of Boone County, is here today along with some Hallsville 4-H members. Commissioner Thompson stated she wanted to welcome everyone and thank them for coming, along with thanking them for allowing the Commission to take part in celebrating their 70<sup>th</sup> anniversary.

Commissioner Thompson read the following proclamation:

Whereas, 4-H, founded as a youth program in Clark County, Ohio, in 1902, is America's largest youth development organization, supporting nearly 6 million youth across the country and encouraging them with the motto, "To Make the Best Better"; and

Whereas, Hallsville Go-Getters 4-H Club was chartered in 1951, with 52 members led by Club Leader Omer Jay Pickett and Club President Nancy Austene; and

*Whereas,* now, 70 years later, membership in the Hallsville Go-Getters 4-H Club has nearly doubled, reaching 100 members in 2021; and

Whereas, Hallsville Go-Getters 4-H Club's purpose is to help youth develop life skills such as self-concept, relating to others, and decision making, as well as the physical and practical skills for which 4-H is typically known; and

whereas, since its inception 70 years ago, Hallsville Go-Getters 4-H has helped over 4,000 youth to become confident, independent, resilient, and compassionate leaders by providing an organized means for youth to learn from the knowledge of adult and youth leaders, an enjoyable atmosphere for learning, and an opportunity to experience community interaction through volunteerism and community service; and

Whereas, youth participating in 4-H are able to learn-by-doing through hands-on projects in the important areas of health, science, agriculture, and civic engagement; and

Whereas, the variety of community service projects performed by the members of Hallsville Go-Getters 4-H Club has shown, to club members and the public alike, the multitude of ways the skills they learn in 4-H can be used to make a positive impact on the lives of everyone in their community; and

Whereas, with over 1,000 volunteers, the Hallsville Go-Getters 4-H network provides caring and supportive mentoring to all 4-Hers, helping them to grow into true leaders, entrepreneurs, and visionaries.

Therefore, the Boone County Commission does hereby recognize the Seventieth Anniversary of the Hallsville Go-Getters 4-H Club and honors all of its club members for the significant impact they have made and continue to make by empowering youth with the skills they need to lead for a lifetime.

2. First Reading: Contract 33-31AUG21 - Pre-Printed Envelopes for the Boone County Collector

Senior Buyer Liz Palazzolo read the following memo: Request for Bid 33-31AUG21 solicited sealed bids for Pre-Printed Envelopes for the Boone County Collector. A total of 6 responses were received: 3 bids and 3 "No Bids." The 3 bids were reviewed by Boone County Collector Brian McCollum; Chief Deputy Collector Crystal DeSilva; and Lead Deputy Collector Grace Hayes. The Purchasing Department conducted the cost evaluation.

The lowest priced bid was determined to be nonresponsive because of past unsuccessful performance history with the County. The County is preparing to award the contract for Pre-Printed Envelopes to Cenveo Worldwide Limited of Villa Ridge, Missouri as the lowest priced responsive bid presenting compliant sample envelopes and positive past experience.

The contract period will run from September 21, 2021 through September 20, 2022.

Payment will be paid from the following Department 1150 - Collector/Account 23001 - Printing for \$13,192.50.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
