1. First and Second Reading: Proclamation Honoring Kathleen Weinschenk

Whereas, seventy-eight years ago on January 5, 1943, Kathleen Goff Weinschenk was born

in Little Rock, Arkansas; and

Whereas, Kathleen came to Columbia, Missouri, in 1969 to study at the University of

Missouri where she earned her bachelor's degrees in psychology and sociology and

her master's degree in education; and

Whereas, Kathleen became a fixture of the Boone County arts community and was prolific in graphic arts and poetry; and

Whereas, Kathleen lived her commitment to public service and investing in the community by serving as an integral part of the First Night board of directors, PedNet Coalition, Columbia Disabilities Commission, Services for Independent Living Board, and the Unity Center of Columbia; and

Whereas, Kathleen was known for her passionate advocacy and civic engagement on behalf of individuals with disabilities, including as lead plaintiff in the now-seminal voting rights case in Missouri, Weinschenk v. State (2006); and,

Whereas, throughout her lifetime, Kathleen was a ubiquitous force of positivity and good in the community.

Therefore, the Boone County Commission does hereby recognize Kathleen Goff Weinschenk for her significant contributions to the Boone County community and her remarkable lifetime of service and work in the pursuit of a better world.

2. First Reading: Cooperative Contract R-TC-17006 – On-Line Market for the Purchase of Good and Services – Amazon

Senior Buyer Liz Palazzolo read the following memo:

Purchasing requests permission to use contract R-TC-17006 for the On-Line Market for the Purchase of Goods and Services with Amazon Services LLC. The contract has been established as a cooperative contract through Omnia Partners/U.S. Communities. The contract allows the County to use the Amazon Business portal to purchase goods and services using the County procurement card. The products and services purchased would not be the products and services available to County departments on current County contracts. Amazon Business offers price discounts, tax-exempt purchasing, and allows for spend controls set by each individual office. Amazon Business does not sign agreements with contract users so there is no contract documentation the County would sign with Amazon.

This is a Countywide Term and Supply contract.

3. First Reading: Cooperative Contract CC200147001 – State of Missouri Office of Administration contract for Ammunition with Gulf States Distributors, Inc.- Term & Supply

Senior Buyer Liz Palazzolo read the following memo: Purchasing requests permission to use contract CC200147001 for Ammunition established by the State of Missouri Office of Administration with Gulf States Distributors, Inc. of Montgomery, Alabama as a cooperative contract. The contract is intended for purchases made by the Boone County Sheriff's Office.

7. First Reading: State of Missouri Application for Federal/State Public Assistance Deputy Director of Emergency Management Chris Kelley stated his department is asking that the Commission approve the application for public assistance money through FEMA regarding a disaster declaration from storms occurring in Boone County between June 24, 2021, and July 1, 2021. Deputy Director Kelley stated, at this point, the infrastructure affected was roadways maintained by Boone County Road & Bridge. Deputy Director Kelley stated, with labor and

cost, they are currently looking at around \$150,000.00 in preliminary damage charges along with overtime. Deputy Director Kelley stated this grant is a 75% match from the Federal Government.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. First Reading: BCJC Administrative Authority to purchase radio equipment

Director of Joint Communications Chad Martin stated this is in reference to discussions they have had recently in other meetings to give Joint Communications the authority to purchase radio equipment up to \$7,500.00 using a budget specific for this in Department 2704 Account 92300 in the amount of \$30,000.00. Director Martin stated the authority would be granted for the remainder of 2021 and Fiscal Year 2022.
