The meeting was called to order at 1:30pm.

Boone County Department of Public Health and Human Services

1. First Reading: Boone County PDMP Contract Renewal with St. Louis County

Assistant Director of Boone County Public Health and Human Services Scott Clardy stated this is the annual amendment for renewing the agreement with St. Louis County to implement the PDMP in Boone County, outside of Columbia. Assistant Director Clardy stated St. Louis County provides the framework for the prescription drug program, which means they provide the electronic database that physicians and providers use across Boone County to check a person's prescription, particularly opioids. Assistant Director Clardy stated they also provide a

quarterly report of what prescriptions are looking like in Boone County. He stated these services are free to Boone County and the contract will start October 28, 2021.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Boone County Sheriff Office

2. First Reading: Miller County Sheriff Department K-9 Basic Training Contract

Boone County Sheriff's Office Captain Brian Leer stated the Miller County Sheriff's Department has reached out to them and has asked them to train one of their handlers and K-9 units. Captain Leer stated this is an 8-week training that is set to begin on October 18, 2021. Captain Leer stated the contract amount is \$3,600.00, due to the Sheriff's Office by the completion of the training.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Prosecuting Attorney

3. First Reading: VOCA Contract Extension 10/1/2021 - 12/31/2021

Second Assistant Prosecuting Attorney Nicholas Komoroski stated this is a three-month extension of the Victims of Crime Act (VOCA) contract. Mr. Komoroski stated previously, there was a twenty-three-month contract where the Department of Social Services provided funding to the office to pay for two victim advocates, one full time victim specialist and one part time victim specialist. Mr. Komoroski stated the Department of Social Services is now reviewing a longer-term contract, and what they have said to the courts is that they want to extend the previous contract by three months.

5. First Reading: Contract Amendment #1 for Signature: 34-18JUL19 - Access to Healthy Food with Sustainable Farms and Communities, Inc

Director of Purchasing Melinda Bobbitt read the following memo: Attached for signature is contract amendment #1 to 34-18JUL19 – Access to Healthy Food with Sustainable Farms & Communities, Inc. of Columbia, Missouri.

This amendment adds a supplemental funding increase through December 31, 2021 for the following:

7,518 Units of SNAP/WIC Matching at \$1.25 per voucher for a total not to exceed amount of \$9,397.50.

Invoices will be paid from department 2162 – CSF Program Funding, account 71106 - Contracted Services. \$1,398,352.44 remains in the budget for Sustainable Farms & Communities, Inc.

Three bids were received. Ryan Beasley with Simon Associates and Doug Coley, Facilities Maintenance Manager recommend award to GBH Builders, Inc. of Jefferson City, Missouri for offering the lowest and best bid.

This is a project for the Unit Owners Association of the Columbia/Boone County Health Department Condominium. Certification of this contract is not required by County Auditor's office. The only signatures on this contract will be by the vendor and the Condo Board.

Facilities Maintenance

10. First and Second Reading: Budget Revision for the purchase of a dehumidifier for the ECC basement

Director of Facilities Maintenance Doug Coley stated there was a mildew problem that arose about a month ago but was caught early. Director Coley stated he will still have to pay a little over \$10,000.00 for clean up of the mildew in the basement. Director Coley stated there have been some issues at that building and he doesn't feel they have a large enough field that they are putting their water into. Director Coley stated the whole building is geothermal and they use the ground source for heating and cooling and there have been temperatures coming in from the fields of ninety-eight degrees consistently. Director Coley stated what's happening is, in the upper part of the building they want high humidity because they don't want static for the computers, but in the basement, it's a whole different story. Director Coley stated they have not been able to take moisture out of there and that's what precipitated the mildew growth. Director Coley stated he has gotten bids from two different companies to install a dehumidifier in the system in the basement and it was \$7,000.00 - \$9,000.00, so they decided to purchase a dehumidifier like Service Master or Serve Pro would have for around \$2,000.00.

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve moving of funds from Department 2705 Account 71100 to Department 2705 Account 91300 for the purchase of a dehumidifier.
