## 1. First reading approving updated Food Code fees for 2022

Assistant Director of the Columbia/Boone County Department of Public Health and Human Services Scott Clardy stated this will update the basic fees that are charged each year for operating permits, those fees will increase from 8%-9% for most of the area. Mr. Clardy stated they will continue the same amount for temporary food permits and the same amount for reinspection fees. Mr. Clardy stated two new types of fees will be added next year. Mr. Clardy stated effective May 1, 2022 they will be collecting fees for plan reviews, which is for a facility that's either being constructed or having major construction done. Mr. Clardy stated they have charged these fees in the city for awhile and his office is recommending adoption of those fees for the County. Mr. Clardy stated a new fee for concession stands is also going to be added. Mr. Clardy stated concession stands usually operate less than 90 days in a 365-day period, but they are paying the full operating permit fee which is \$220.00 which isn't fair to them. Mr. Clardy stated his office is recommending a \$100.00 fee, one time per year for any concession stands

that operate for no more than 90 days in a 365-day period. Mr. Clardy stated this will only apply to concession stands that sell potentially "hazardous foods", which is most of them.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Senior Buyer Liz Palazzolo read the following memo: Attached for signature is a non-bid contract # 40-30SEP22C – Battery PM's in UPS System with EnerSys Energy Products INC. of Reading, Pennsylvania. This is to provide service for the 2 cabinets of 30 batteries each for the UPS System located at Joint Communications.

All other terms, conditions, including pricing of the original agreement remain unchanged.

Payment will be paid from the following Department 2010 - Assessment/Account 23001 - Printing for \$11,000.00.
