# 3. Public Comment

# 4. Commissioner Reports

Commissioner Thompson stated she was on a conference call yesterday afternoon with the National Judicial taskforce on mental health and the justice system. Commissioner Thompson stated she is the NACo liaison for that task force. Commissioner Thompson stated it's great to see the efforts made across the country to improve the quality of justice for individuals with behavioral health issues in the court system. Commissioner Thompson stated the focus of the conference call was competency questions in the court, and how to get the competency evaluations done more quickly, more accurately and in a way that gets people into the right places sooner. Commissioner Thompson stated these issues are being struggled with here locally. There are not enough beds and people sit in our County Jail even when the court has ordered them evaluated. Commissioner Thompson stated sometimes these individuals will sit for six months before they can even get a bed for evaluation. Commissioner Thompson stated that's a problem nationwide, and she's hopeful the work of the task force can help find ways to get the competency evaluations to occur more rapidly.
