The meeting was called to order at 1:30pm.

Assessor

1. Second Reading: 2022-2023 Assessment Maintenance Plan (First Read 12.21.21)

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby accept the attached 2022 - 2023 Assessment Maintenance Plan submitted by the County Assessor.

It is further ordered the Boone County Commissioners are hereby authorized to sign said 2022 - 2023 Assessment Maintenance Plan.

Commissioner Thompson seconded the motion. The motion carried 3 to 0. **Order #520-2021**

Human Resources

2. First and Second Reading: 2022 Boone County Pay Plan

Risk Management Specialist Angela Wehmeyer stated this is the pay plan reflected in the FY22 budget. Commissioner Thompson added that the information attached for the record has every position throughout the County, with the range for that position with the hourly minimum and maximum and will be for the 2022 cycle.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the attached 2022 Pay Plan, which reflects the appropriation in Boone County 2022 budget.

Commissioner Aldred seconded the motion. The motion carried 3 to 0. **Order #521-2021**

Resource Management

3. First Reading: Building Permit Fee Adjustment

Director of Resource Management Bill Florea stated they are asking for two adjustments to the building permit fee schedule. Director Florea stated one is a \$30.00 plan review fee for solar installations on residential properties. Director Florea stated secondly, they are looking at pole structures greater than 3,000 square feet, which have to be built under the IVC code, not the residential code, so a plan review is done on those to ensure structural integrity has been addressed. They would like to charge a \$75.00 fee for those.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

4. First Reading: CAM Agreement with USGS for Hinkson Creek Water/Chemical Analysis – Investigation of anthropogenic contaminants in Hinkson Creek

Urban Hydrologist Lynne Hooper stated they will be looking at a long list of chemical constituents, and this kind of chemical analysis hasn't been performed for several years. Ms. Hooper stated this is a CAM project so the cost will be divided equally between the three partners. Ms. Hooper stated the County Commission has already approved the intergovernmental agreement to cover the cost of the project.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

5. First Reading: Annual Consultant Service Agreements with: A2V Partners LLC, Allstate Consultants, Engineering Surveys & Services LLC, Great River Engineering, Howe Company LLC, McClure Engineering CO and PW Architects

Director of Resource Management Bill Florea stated this is their standard Consultant Services Agreement that Resource Management brings to the Commission every year. Budget Administrator Kelle Westcott stated A2V Partners LLC has not been on the list in previous years, but the Boone County Sheriff's Office utilizes them so they have been added this year.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

6. Second Reading: Land Use Permit Fee Adjustment (First Read 12.21.21)

Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve the land use permit fees per the attachment proposed by the Resource Management Department.

Fees will be effective January 1, 2022.

8. First Reading: Contract Amendment #2 funded from the Community Health/Medical Fund Strategic Opportunity

Director of Community Services Joanne Nelson stated this is a Contract Amendment for In2Action for \$37,636.20. Director Nelson stated this program offers peer support and case

management for justice-involved individuals in Boone County, with the focus on those most recently released from jail or prison. Director Nelson stated the peer support services help individuals with substance use and/or mental health disorders to become or stay engaged in the recovery process.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

9. First Reading: Cora Community Outreach

Director of Community Services Joanne Nelson stated this is a strategic innovation opportunity funded through the Children's Services Fund to be extended from January 1, 2022, until December 31, 2022, for \$219,997.16. Director Nelson stated the program offers out of school programing, case management and community-based mentoring, both for individuals and groups, for at risk male student athletes. Director Nelson stated this program provides access to opportunities and resources that students need in order to succeed.
