The meeting was called to order at 1:30pm.

Health Department

1. First and Second Reading: Public Nuisance Parcel #17-313-11-01-152.00 01

Environmental Public Health Specialist Boone County Health Department, Kristine Vellema stated there are some photographs of trash and boxes by the front door and stated an abatement of this property has been done before. Ms. Vellema stated she hasn't gotten any response from the property owner. Commissioner Atwill asked if there was anyone on the phone on behalf of

the owner. Amanda Woodson stated she is "standing in" for owner Jeanne Buckman. Ms. Woodson stated they have been trying to evict the tenants, for a year, who currently reside at this property. Ms. Woodson stated every time they get the property cleaned up, they "do it to us" again. Ms. Woodson stated she has been at this location all week cleaning it up and asked if anyone had been out to inspect it today. Ms. Vellema stated there were still some boxes and trash piled by the front door when she was out there this morning. Ms. Woodson stated she just finished moving things within the last hour. Ms. Woodson stated she sends the tenants the same ordinance she receives in the mail from the Health Department but states the tenants "don't care." Ms. Vellema explained that if Ms. Woodson would provide her phone number, she would certainly be willing to work with her on getting this cleaned up.

Commissioner Thompson moved now on this 20th day of January 2022, the County Commission of Boone County, Missouri met in regular session and entered the following findings of fact, conclusions of law and order for abatement of nuisance:

Findings of Fact and Conclusions of Law

The County Commission finds as fact and concludes as a matter of law the following:

1. The Boone County Code of Health Regulations (the "Code") are officially noticed and are made a part of the record in this proceeding.

2. The City of Columbia/Boone County Health Department administrative record is made a part of the record in this proceeding and incorporated herein by reference. In addition, any live testimony of the official(s) of the department and other interested persons are made a part of the record in this proceeding.

3. A public nuisance exists described as follows: junk, trash, rubbish, garbage and other

refuse on the premises.

4. The location of the public nuisance is as follows: 800 Demaret Drive, Fairway Meadows Subdivision, Replat 1, Block 4, Lot 23, a/k/a parcel# 17-313-11-01-152.00 01, Section 11, Township 48, Range 12 as shown in deed book 0419 page 0203, Boone County.

5. The specific violation of the Code is: junk, trash, rubbish, garbage and other refuse in

violation of section 6.5 of the Code.

6. The Health Director's designated Health Official made the above determination of the existence of the public nuisance at the above location. Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 5th day of January to the property owner.

7. The above described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner was given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above described property as a special tax bill and added to the real estate taxes for said property for the current year.

8. No credible evidence has been presented at the hearing to demonstrate that no public nuisance exists or that abatement has been performed or is unnecessary; accordingly, in accordance with section 6.10.2 of the Code and section 67.402, RSMo, the County Commission finds and determines from the credible evidence presented that a public

nuisance exists at the above location which requires abatement and that the parties responsible for abating such nuisance have failed to do so as required by the Health Director or Official's original order referred to above.

Order For Abatement Chargeable As a Special Assessment To The Property

Based upon the foregoing, the County Commission hereby orders abatement of the above described public nuisance at public expense and the Health Director is hereby authorized and directed to carry out this order.

It is further ordered and directed that the Health Director submit a bill for the cost and expense of abatement to the County Clerk for attachment to this order and that the County Clerk submit a certified copy of this order and such bill to the County Collector for inclusion as a special assessment on the real property tax bill for the above described property for the current year in accordance with section 67.402, RSMo.

10. Second Reading: Commission Order calling for a special election on April 5, 2022 on the question of whether to impose a local use tax (First Read 01.18.22)

Columbia Chamber of Commerce President Matt McCormick asked, on behalf of the Chamber, that the Commission move forward with the special election for the use tax and this ballot language. Mr. McCormick stated the Chamber would like for the County to be clear on how the use tax on internet sales would be used, and that it would mirror image Boone County's current sales tax structure. Commissioner Atwill stated the Commission appreciates the support of the Columbia Chamber of Commerce, and said to keep in mind it's not a new tax; it's a tax that needs to be imposed on shipments from out-of-state by companies that don't have physical presence in Boone County. Commissioner Atwill stated it's important the County gets it passed, if that's possible.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby impose its local use tax pursuant to the provisions of RSMo §144.757, at the same rate as the total county sales tax, currently one and three quarters percent (1.75%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action.

The imposition of this use tax shall be effective only after approval of a majority of the qualified voters casting a ballot at a county special election. It is further ordered that the County Commission of the County of Boone hereby calls for an election to be held on Tuesday the **5th**

day of April, 2022, for the purpose of submitting to the voters the proposition contained in the following Notice of Election and Sample Ballot:

Notice is hereby given to the qualified voters of the County of Boone that the County Commission of said county has called an election to be held in said county on the **5th day of April**, **2022**, from and between the hours of six o'clock a.m. and seven o'clock p.m. on said date, to vote on the proposition contained in the following sample ballot:

Commissioner Atwill explained that the abatement issue has already been discussed and that the caller would be hearing from who he assumed was her landlord. The caller stated the owner is Jeanne Buckman and the manager is Keith Taylor. The caller went on to say that trash removal is impossible for her because there's no dumpster there, the owner had it removed about two years ago. The caller stated she has tried to keep the yard up, and asked with nowhere to put the trash, what is she supposed to do? Commissioner Atwill advised that she would be able to take that up with a County representative and the owner, as they were probably going to stop by her house soon to discuss it.
