This Amendment extends the Contract for the period of January 1, 2022 through December 31, 2022. It adds a renewal amount of \$24,999.60.

7. First Reading: Show - Me State Games

Commissioner Thompson stated this is to place the ongoing commitment by the Show-Me State Games to host the games here in Boone County on the record. Commissioner Thompson stated the payment by Boone County of \$18,000.00 is to support those games in 2022, stating the

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. Second Reading: Acknowledging receipt of transmittal regarding the Columbia Mall TDD (First Read 02.01.22)

Commissioner Thompson stated she would like to again thank Commissioner Atwill and Boone County Counselor CJ Dykhouse for making it very clear about this action being administrative, because there is no discretion involved on the part of the Commission. Commissioner Thompson stated the only action from the Commission is to spread it on the record.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone, as required by statute, specifically RSMo Sec. 238.216.6, does hereby spread upon the records of the Boone County Commission the transmittal received concerning Boone County Circuit Court Case No.: 05BA-CV03760 involving the Columbia Mall Transportation Development District (Columbia Mall TDD). The Court Order dated January 24, 2022 extends the Columbia Mall TDD's sales tax of one half of one percent (0.5%) until September 30, 2044 for the purposes of funding the completed transportation project and administrative costs of the district.

Commissioner Aldred seconded the motion. The motion carried 3 to 0. **Order #55-2022**

10. Commissioner Reports

Commissioner Thompson stated Mr. Donelon left her a message this morning to let them know the public hearing scheduled on February 10, 2022, with respect to Grace Lane and the proposed development on Grace Lane, has been postponed until a time to be determined. Commissioner Thompson stated all three Commissioners will be engaged in mandatory training with the County Commissioners Association of Missouri from tomorrow until Friday. Commissioner Thompson stated on Friday, Commissioner Aldred and herself will be heading to Washington D.C. for the National Association of Counties Legislative meeting. Commissioner Thompson stated they will return next Tuesday, February 15, 2022. Commissioner Thompson went on to say she has been working as the NACo liaison to a group of State Supreme Court Justices. Commissioner Thompson stated they are working on the problem of over representation of mental illness in our criminal justice system. Commissioner Thompson stated one of the justices on this taskforce will be joining her in D.C. in the Justice and Public Safety Committee Meeting on Saturday and the Board of Directors meeting on Sunday, to explain the work of the taskforce.
