The meeting was called to order at 9:30am.

#### **Health Department**

#### 1. First and Second Reading: Nuisance Abatement - Parcel 12-200-03-00-024.00 01

Environmental Public Health Specialist Garth Baker stated they received complaints in October 2021 regarding a person living in the shop area and, although it's a different issue, he isn't sure where their sewage is going, and there are no utilities. Mr. Baker stated, as shown in the photos, there is junk all around the area. Mr. Baker stated there is a junk truck, junk trailers, and tires throughout the property. Mr. Baker stated they have received a few more complaints recently and he sent them a notice in November 2021 and a second notice in December 2021. Mr. Baker stated he took photos of the area in February 2022. Commissioner Atwill asked if there was anyone on the phone or in person to represent the owner of the property. After no one spoke up, Commissioner Atwill asked for questions or a motion.

Commissioner Thompson moved on this 8<sup>th</sup> day of March 2022, the County Commission of Boone County, Missouri met in regular session and entered the following findings of fact, conclusions of law and order for abatement of nuisance:

## Findings of Fact and Conclusions of Law

The County Commission finds as fact and concludes as a matter of law the following:

- 1. The Boone County Code of Health Regulations (the "Code") are officially noticed and are made a part of the record in this proceeding.
- 2. The City of Columbia/Boone County Health Department administrative record is made a part of the record in this proceeding and incorporated herein by reference. In addition, any live testimony of the official(s) of the department and other interested persons are made a part of the record in this proceeding.
- 3. A public nuisance exists described as follows: trash, rubbish, garbage, broken furniture, and tires on the premises.
- 4. The location of the public nuisance is as follows N NORTH BROWNS STATION RD, Columbia, MO, a/k/a parcel# 12-200-03-00-024.00 01, Section 3, Township 49, Range 12 as shown by deed book 1166 page 0079, Boone County

Notice of that determination and the requirement for abatement was given in accordance with section 6.10.1 of the Code on the 17<sup>th</sup> day of December 2021, to the property owner.
- 7. The above described public nuisance was not abated. As required by section 6.10.2 of the Code, the property owner were given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above described property as a special tax bill and added to the real estate taxes for said property for the current year.
- 8. No credible evidence has been presented at the hearing to demonstrate that no public nuisance exists or that abatement has been performed or is unnecessary; accordingly, in accordance with section 6.10.2 of the Code and section 67.402, RSMo, the County Commission finds and determines from the credible evidence presented that a public nuisance exists at the above location which requires abatement and that the parties responsible for abating such nuisance have failed to do so as required by the Health Director or Official's original order referred to above.

Mr. Baker stated he has spoken with the owner regarding this property and the owner stated he would be cleaning it up. Mr. Baker stated due to the weather, he couldn't get it cleaned up but will have his crew out there today to get it cleaned up. Commissioner Atwill asked if anyone was on the phone or in person to represent the owner. After no one spoke up, Commissioner Atwill asked for questions or a motion.

As required by section 6.10.2 of the Code, the property owner was given notice of the hearing conducted this date before the Boone County Commission for an order to abate the above nuisance at government expense with the cost and expense thereof to be charged against the above described property as a special tax bill and added to the real estate taxes for said property for the current year.

Commissioner Atwill asked if anyone was on the phone or in person to represent the owner. After no one spoke up, Commissioner Atwill asked for questions or a motion.

## 4. First and Second Reading: Nuisance Abatement Parcel 11-903-35-00-007.00 01

Environmental Public Health Specialist Garth Baker stated they received complaints on this property in September, October and November 2021. Mr. Baker stated there have been squatters at the property who have taken it over and covered it with junk. Mr. Baker stated he has been communicating with the owner's caretaker and working with her to get the property cleaned up. Geriatric Care Manager Janie Bailey stated they have posted a demand for possession and have been working with the police since 2021 to try to do trespass warnings, but they have now been advised to go through the eviction process. Ms. Bailey stated there was never a lease and the individuals that are there never had permission to be there. Ms. Bailey stated the owner Joel Putnam lives in an assisted living facility, so she can't have a lot of oversight over the property. Ms. Bailey stated the owner has now hired a lawyer who has filed for a demand of possession and states as soon as they are able to get the eviction put through and get back possession, she has two quotes from two different businesses to get the property cleaned up. Owner Joel Putnam stated she can't get out to her property due to being in a wheelchair and she hasn't been there since 2015. Ms. Putnam stated the last time she was there, she picked up all the lithium batteries that were around, which she states are used to make drugs. Ms. Putnam stated she is in the process of selling her other home but doesn't know what to do about the woman living out there. Ms. Putnam stated the property is covered in trash; they have asked the lady to leave but she hasn't left. Ms. Putnam stated she doesn't even know they lady's name, but she knows there are no utilities on at the property and that no one has permission to be living there. Commissioner Thompson explained to Ms. Putnam that now, Commissioner Atwill will ask for a motion so an order will be put in place, so Mr. Baker at the Health Department has the authority to continue working with her to get this resolved.
