The meeting was called to order at 1:30pm.

#### Purchasing

1. First Reading: Contract 04-02MAR22 - Carpet Cleaning Services - Term & Supply Commissioner Thompson read the following memo: Request for Bid 04-02MAR22 – Carpet Cleaning Services – Term & Supply opened on March 2, 2022. Two (2) bids were received. Facilities Maintenance recommends award to American Heritage Carpet Cleaning as primary contractor and Sappington's Carpet Care as secondary contractor.

Invoices will be paid from departments 6101 – Facilities Maintenance Housekeeping & Custodial Services and account 60125 – Custodial/Janitorial Service.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

2. Second Reading: First Reading: Contract Amendment #1 CC220022004 - 2022 Police SUV- additional for Boone County Sheriff's Office (First Read 03.15.22) Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve Amendment #1 to Contract CC220022004 with Joe Machens Ford Lincoln of Columbia, Missouri which adds the purchase of one additional pursuit vehicle for the Boone County Sheriff's Office. The Co-Op Contract was initially awarded February 8, 2022 (Commission Order 52-2022). The vehicle description is set out in the attached paperwork. This vehicle replaces a vehicle that was totaled in an accident. The disposal form is attached.

All other terms, conditions, including pricing of the original agreement remain unchanged.

Payment for the vehicle will be paid from Department 2901, Sheriff Operations LE Sales Tax, Assessment - Account 92400, Replacement Autos and Trucks in the amount of \$36,938.00.

## 3. Second Reading: Purchasing Director Authority to Sign Contracts (First Read 03.15.22)

Commissioner Thompson stated the language for this has gone through the County Counselor and this essentially completes the circle for the County Purchasing Director to be treated as the Purchasing Agent under RSMo Sec. 50.753. Commissioner Thompson stated this will give the Purchasing Director authority to sign smaller contracts throughout the month and then present those at the end of the month to Commission. Commissioner Thompson stated this isn't for big items like capital projects, it's for the smaller things that have already gone through the budget process.

Commissioner Thompson moved now on this day, the County Commission of the County of Boone does hereby approve the request for the Purchasing Director to be granted authority to sign Contracts and Amendments excluding capital projects and any project not in the current Fiscal Year Budget where there are no appropriations.

The Purchasing Director is hereby designated the County's Purchasing Agent as contemplated in RSMo Sec. 50.753. In order to maintain public transparency about the award of contracts, the Purchasing Department will read a Memorandum at the beginning of each month in a Commission meeting confirming the list of Contracts signed by the Purchasing Director during the previous month, for which the Commission will acknowledge receipt of via Commission Order.

This designation of authority will become effective April 1, 2022.
