Commissioner Aldred moved now on this day, the County Commission of the County of Boone does hereby approve Amendment #1 to Contract 52-03DEC19 with Southern Uniform & Equipment for Ballistic/Stab Resistant Body Armor that was awarded December 31, 2019 (Commission Order 552-2019) and assigns the Contract from Southern Uniform & Equipment to Southern Uniform & Tactical, Inc.

The amendment also cites the new Finance Enterprise contract number, C000291.

Resource Management recommends award to CL Richardson Construction Co., Inc.

Cost of the Contract is \$123,964.00. There will be a10% contingency of \$12,396.40 added for a Purchase Order total of \$136,360.40, which will be paid from Department 2041 - R&B RM Road Infrastructure Rehab and Preservation, Account 71202 – Contractor Costs.

The Boone County budgeted amount for this contract is \$200,000.

6. Second Reading: Award 162-123122SS - Crime Point Hermit Camera System for the Boone County Sheriff (03.31.22)

The Purchasing Department requests approval of Single Feasible Source 162-123122SS and Contract C000390 that results and is being established on behalf of the Boone County Sheriff's Office.

The single feasible source has been advertised in both the Missourian and the Columbia Tribune. No other vendors have come forth to indicate that they are able to provide it.

This is a one-time acquisition of equipment that carries a two-year manufacturer's warranty.

Three bids and three "No Bids" were received.

The contract for Detainee Hygiene/Other Supplies and Detainee Uniform Items will be awarded to the low bidder for all items, Bob Barker Company, Inc. of Fuquay Varina, North Carolina with the exception of line item 4.10.4 (wool blanket) which will not be awarded.

The initial contract period will run from April 1, 2022 through March 31, 2023 and includes three (3) one-year renewal options.

8. First Reading: Request for an extended training overlap period for position 808, Senior Accountant/Financial Analyst, through August 31, 2022

Director of Human Resources Jenna Redel stated the Auditor's Office recently learned that one of their employees who has been with the County for over twenty years, is planning to retire. Director Redel stated that the office has come to an agreement with the current employee, who is willing to stay until August 31, 2022, which is the due date for individual offices to turn in their budget for 2023. Director Redel stated the Senior Accountant who is leaving has a major role in all things budgetary with Boone County, so this request would allow the Auditor to hire someone into that position and allow the current Senior Accountant to train her replacement through this full budget cycle.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

9. First Reading: Request to transfer above the Flexible Transfer Salary, position 808, Senior Accountant/Financial Analyst

Director of Human Resources Jenna Redel stated this request is to be able to hire someone into the Senior Accountant position at \$3,078.00 above the flexible hiring limit for the position. Director Redel stated the person the Auditor's Office is intending to move into the Senior Accountant position is already with the County and has been with the Auditor's Office a little more than eight years. Director Redel stated the amount they are requesting to start her in the position at is market competitive with where the City of Columbia and Jefferson City currently have their Senior Accountants. Commissioner Thompson added that this person has demonstrated such a growth trajectory in the last couple of years that has been astounding. Commissioner Thompson stated she feels this is a good move on the part of the Auditors office.

16. First Reading: Acknowledging receipt of the Chapter 100 compliance report from Dana Axle

Boone County Counselor CJ Dykhouse stated in connection with their pending Chapter 100, they have provisions in the performance agreement for clawbacks if certain job targets aren't met. Counselor Dykhouse stated he is happy to report, that, in the instance of Dana Axle, 2017 series bond issuance, the company has made all its targets and has been above it's targets for the tax year 2021. Columbia's Plant Manager Scott Wright stated they had a challenging year last year where they saw customer shutdowns due to component shortages. Mr. Wright stated they had their share of challenges, but they continued to see strong sales at the end of last year into this year and he has been getting positive feedback out of the workforce, and they hope to continue growing in 2022.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

17. First Reading: Budget Amendment for Dept 2983

Boone County Counselor CJ Dykhouse stated this Budget Amendment is to appropriate funds from the American Recovery and Protection Act to fund the County's anticipated contribution to the Boone County Nature School thorough Columbia Public Schools. Counselor Dykhouse stated this is for \$250,000.00, and while they wait for the second reading of the item, they are trying to get the agreement through the Columbia Public Schools Board of Education. Counselor Dykhouse stated after that is done, they will meet up on the other end with final action on the Budget Amendment which will have a public hearing and then the Commission can take up and approve the Boone County Nature School funding agreement if they so choose.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
