The meeting was called to order at 1:30pm.

Sheriff's Office

1. First Reading: Missouri Department of Transportation Highway Safety and Traffic Division Contracts

Captain Brian Leer stated this is an ongoing program that they have established and had going for several years with MoDOT. Captain Leer stated out of these four contracts, two of them are for positions they currently have filled, and the continuation contract funds one of the positions at 50% and one of them at 75% for the upcoming year, which runs October through September of 2023. Captain Leer stated the other two grants continue to have two deputies, for which the state will continue to provide funding at 50%.
