The meeting was called to order at 9:30am and roll call was taken.

Facilities Maintenance

1. First Reading: Budget Amendment for Dept 2705 – Geothermal System

Service Coordinator Jody Moore stated this is an Amendment to add money to the outsource services fund for 911. Ms. Moore stated that the building is heated using a geothermal system which has had continuing issues with the water temperatures going out and coming into the building. Ms. Moore stated the water coming out of the building ranges from 90 to 95 degrees and should be passing through the system and some of the heat dissipating. Ms. Moore stated

what they are seeing is the temperature as the water enters the building is still 90-95 degrees, which isn't so bad in the winter, but in the summer, it's too much for the compressors to cool that temperature.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Road & Bridge

2. First Reading: Budget Amendment for Dept 2040/2042 - Mechanics Tools

Senior Buyer Liz Palazzolo stated she is currently working on a purchase for Road & Bridge from Snap On to purchase additional tools the department needs to take care of personnel gaps.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Emergency Management

3. First Reading: BCOEM — Strategic Plan 2022-2024 Addendum

Deputy Director of Emergency Management Chris Kelley stated he is asking the County to look at this addendum update, as they have changed some completion dates and are looking for it to be approved.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Boone County Sheriff's Office

4. First Reading: K-9 Basic Training Agreement with Caldwell County Sheriff

Captain Brian Leer stated this is a new agency relationship for the Sheriff's Office and they would like his office to train a K-9 and a handler. Captain Leer stated this will be a multipurpose K-9. They do 40 training sessions, and the contract is in the amount of \$4,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

5. First Reading: K-9 Basic Training Agreement with Kirksville Police Department

Captain Brian Leer stated this is an Agreement for a single purpose K-9 over a 20-session training course, and this contract is in the amount of \$2,000.00.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

6. First Reading: Budget Amendment – Dept 1253 – Unspent SCCG Funds from FY2022

Captain Brian Leer stated this is for the State Cyber Crimes Grant which is the main grant by which the Boone County Sheriff's Office Cyber Crime unit is funded. Captain Leer stated this budget amendment is requesting to re-budget the unspent 2022 funds into the 2023 budget. Captain Leer stated, in 2022, they discovered a better software solution, which resulted in savings.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

7. First Reading: Budget Amendment – Dept 1253 – Missouri Internet Crimes Against Children (MOICAC)

Captain Brian Leer stated in December 2022, he was notified that the office was receiving a \$14,000.00 award through year three. They are in their third year of this grant, and this amendment is to cover the purchase of equipment and/or training. Captain Leer stated this amendment is a request to re-budget the remaining Missouri Internet Crimes Against Children award and to budget the 2023 expenditures under this grant.

Commissioner Kendrick stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

8. Second Reading: MoDOT Traffic Grant Applications – First Read 02.16.23

Senior Buyer Liz Palazzolo read the following memo: The formal bid opening for RFB 07-16FEB23 for the Gillespie Bridge Road and Obermiller Road Asphalt Overlay Project for the Boone County Resource Management Department was opened shortly after 11:00am on February 16, 2023. The County received the following two bids:

- (1) Christensen Construction Company of Kingdom City, Missouri total bid price is \$2,333,950.85;
- (2) Capital Paving & Construction, LLC of Columbia, Missouri total bid price is \$2,495,262.76.

The Bid Tabulation is attached including the Engineer's Estimate for the project.

10. First Reading: Award of Contract C000597 from Co-Operative Contract 178-2022 for Motorola Radios – Term & Supply with Wireless, USA

Senior Buyer Liz Palazzolo read the following memo: Purchasing requests approval for awarding Contract C000597 which is Co-operative Contract 178/2022 for Motorola Radios awarded to Wireless USA of Maryland Heights, Missouri for the purchase of specific Motorola two-way radios used by the Boone County Road & Bridge Department and the Boone County Joint Communications Department.

The original Contract period will commence February 22, 2023 and extend through January 15, 2024. There are four (4) one-year renewal options available to renew the contract on a year-to-year basis after the original Contract period.
