#### **Facilities Management**

1. First and Second Reading: Department Name Change - Facilities Maintenance to Facilities Management

3. First Reading: Amendment #1 to C000715 (CC240753003) – Motor Vehicles which cancels the contract for a Silverado for Road & Bridge approved on commission order #32-2024

Buyer Amy Gerskin read the following memo:

Contract C000715 (CC240753003) – Motor Vehicles with Rusty Drewing was approved by commission for award to Rusty Drewing Chevrolet on January 23, 2024, Commission Order #32-2024.

This Amendment cancels the Contract effective January 31, 2024. This is due to an error in the solicitation process at the County that was not in conformity with the specifications of the original State of Missouri QVL.
