Pursuant to RSMo §140.230 the Commission is authorized to approve claims for any tax sale surplus being held by the County Treasurer associated with the County Collector's annual tax sale as part of a redemption or after the expiration of the applicable redemption period. In this instance, the owner of record at the time the subject property went to tax sale was **Dixie L. Bott**, per the vesting deed at Book 397, Page 832, Boone County Records. A lienholder of record, Regions Bank, has assigned the tax sale surplus to the Boone County Collector as part of that lienholder's redemption of the property on behalf of the owner of record. 
