Her knowledge and experience with the County uniquely equip her to assume the new and increased responsibilities of the Senior Accountant position with less oversight and training than would be necessary for an external candidate with less experience. Throughout her 8year tenure, Heather consistently demonstrates a strong work ethic, commitment to teamwork, process improvement, accuracy, and completeness. These are the qualities necessary to be successful in the Senior Accountant position.
