

**PURCHASE AGREEMENT
FOR
CARTEGRAPH SOLUTIONS SUBSCRIPTIONS AND SUPPORT**

THIS AGREEMENT, County Contract **C000501**, Sole Source 166-123123SS, dated the 19th day of January 2023 is made between Boone County, Missouri, a political subdivision of the State of Missouri through the Boone County Commission, herein "County" and **Cartegraph Systems LLC** herein "Contractor."

IN CONSIDERATION of the parties' performance of the respective obligations contained herein, the parties agree as follows:

1. **Contract Documents** - This agreement for Cartegraph Solutions Subscriptions and Support shall be numbered **C000501** and results from Sole Source 166-123123SS; it shall incorporate **Attachment One**, the Cartegraph Solutions Master Agreement dated 12/07/2022 and Boone County's Standard Terms and Conditions (as amended and attached). All such documents shall constitute the contract documents which are incorporated herein by reference. During the Term of this contract, service or product data, specification and literature submitted with the contractor's response may be maintained in the County Purchasing Office sole source file for this contract if not attached. In the event of conflict between any of the foregoing documents, this Purchase Agreement and Boone County's Standard Terms and Conditions (as amended and attached) shall prevail and control. All transactions under the Purchase Agreement must reference the contract number referenced above.

2. **Purchase** - The County agrees to purchase from the contractor and the contractor agrees to supply the County with an annual subscription for the following as shown in Cartegraph Solutions Master Agreement (Attachment One):

3. **Contract Term**- The contract shall commence **February 01, 2023 through January 31, 2024**. The contract shall be renewable for two (2) one-year periods subsequent to this initial period.

4. **Billing and Payment** - All billing shall be invoiced to the ordering Boone County office. Billings may only include the prices listed in the contractor's pricing. No additional fees for paperwork processing, labor, or Missouri sales and use taxes shall be included as additional charges in excess of the charges in the contractor's

pricing. The County agrees to pay all invoices within thirty days of receipt. In the event of a billing dispute, the County reserves the right to withhold payment on the disputed amount; in the event the billing dispute is resolved in favor of the contractor, the County agrees to pay interest at a rate of 9% per annum on disputed amounts withheld commencing from the last date that payment was due.

5. **Binding Effect** - This agreement shall be binding upon the parties hereto and their successors and assigns for so long as this agreement remains in full force and effect.


6. **Termination** - This agreement may be terminated by either party upon thirty days advance written notice for any of the following reasons or under any of the following circumstances:

- a. Either party may terminate this agreement due to material breach of any term or condition of this agreement following written notice with at least a thirty day opportunity to cure, or
- b. If appropriations are not made available and budgeted for any calendar year. By executing this contract, the County represents that it has appropriated funds for the first year of this contract. After the first year, this contract may be terminated with at least sixty (60) days written notice prior to the software anniversary date without penalty if funds are not appropriated for the next succeeding contract year. With respect to software, the County will be responsible for payment of the annual software fee due prior to the end of the contract year where such termination is to take effect, and any payments made for the software shall be non-refundable.




