Incident: CHECKPOINT ARREST FOR POSSESSION AND
TRAFFICKING OF A CONTROLLED SUBSTANCE

Location: SHALIMAR DRIVE AND HIGHWAY 763

Details:

ON 07-26-2008 AT ABOUT 0100 HOURS, DURING THE SCHEDULED SOBRIETY CHECKPOINT DEPUTIES CONTACTED THE DRIVER OF A RED 2008 CHEVROLET IMPALA BEARING KANSAS REGISTRATION. THE DRIVER, IDENTIFIED AS DEMOND WILLIAMS A 25 YEAR OLD MALE FROM COLUMBIA, WAS CONTACTED AND ARRESTED FOR DRIVING WITH A SUSPENDED/REVOKED DRIVER'S LICENSE. DURING A SEARCH INCIDENT TO THE ARREST MR. WILLIAMS WAS FOUND TO BE IN POSSESSION OF 8 OUNCES OF INDIVIDUALLY PACKAGED ROCKS OF CRACK COCAINE. HE WAS ALSO IN POSSESSION OF A TABLET OF MDMA MORE COMMONLY KNOWN AS "ECSTASY".

MR. WILLIAMS WAS CHARGED WITH DRIVING WHILE SUSPENDED (RSMO 302.321), POSSESSION OF A CONTROLLED SUBSTANCE WHILE OPERATING A MOTOR VEHICLE (RSMO 195.202) AND TRAFFICKING IN DRUGS/ATTEMPT TO TRAFFIC IN DRUGS (RSMO 195.222).

THE PASSENGER IN THE VEHICLE, TRIMAYNE D. ALLEN, WAS IN POSSESSION OF A QUANTITY OF MDMA "ECSTASY" TABLETS. MR. ALLEN WAS ARRESTED ON POSSESSION OF A CONTROLLED SUBSTANCE OTHER THAN 35 GRAMS OF MARIJUANA (RSMO 195.202).

All suspects are considered innocent until proven guilty in a court of law.
