Media Release RESISTING ARREST

Incident: Resisting arrest, Felon in Possession of a Firearm, Possession of a

Controlled Substance

Location: Patton Street at Ogden Drive in Sturgeon

Details:

On 06-08-2011 at 4:46 P.M. a Deputy with the Boone County Sheriff's Department assisted a Sturgeon Police Officer with a traffic stop for a registration violation at the intersection of Patton Street and Ogden Drive. A passenger in the vehicle, 43 year old David Ardrey of Hannibal MO, falsely identified himself using an identification card issued out of the state of Texas of a deceased individual.

Mr. Ardrey exited the vehicle and assaulted the Deputy by pushing him and ripping his uniform shirt. The Deputy attempted to arrest Mr. Ardrey, however, Mr. Ardrey resisted his efforts. Eventually Mr. Ardrey was taken into custody and placed in the backseat of the Deputies patrol vehicle.

While Mr. Ardrey was being searched incident to his arrest, the Deputy located some Hydrocodone pills in his pocket. The Deputy also located a fixed blade style knife in a sheath concealed inside Mr. Ardrey's shirt in his waistband.

While the Deputy and the Sturgeon Police Officer were attempting to complete the traffic stop with the other occupants of the vehicle, Mr. Ardrey was able to move his handcuffs from behind his back to the front. Mr. Ardrey kicked out the window of the patrol vehicle, and climbed out halfway through the broken window. Mr. Ardrey was placed all the way back inside the vehicle while the Deputy retrieved leg shackles and a hobble restraint.

Mr. Ardrey was removed from the vehicle so the leg shackles could be placed on his legs. Mr. Ardrey resisted the Deputies efforts to place him on the ground to put the leg shackles on. Mr. Ardrey grabbed the Sturgeon Police Officer's finger during this confrontation and bent it at an

angle while they were attempting to subdue him, causing his finger to be injured. While attempting to place the leg shackles on Mr Ardrey, he attempted to kick the Deputy.

After Mr. Ardrey was taken back into custody this time, he advised the Deputy that he had a shortened "sawed off" style shotgun in the vehicle. Mr. Ardrey has previously been convicted of a felony, and therefore it is unlawful for him to be in possession of a firearm.

It was discovered that Mr. Ardrey had an active arrest warrant for Burglary with a bond of \$25,000.00 and a no bond Probation and Parole violation warrant.

Mr. Ardrey was charged with the following:

2 counts of Assault 3rd Degree of a Law Enforcement Officer with a bond of \$1,000.00 Possession of Certain Weapons with a bond of \$4,500.00 Possession of a Firearm Unlawful for Certain Persons with a bond of \$4,500.00 Unlawful use of a weapon with a bond of \$4,500.00 Identity Theft with a bond of \$4,500.00 Property Damage 1st Degree with a bond of \$4,500.00 Resisting Arrest with a bond of \$4,500.00 Escape from Custody with a bond of \$4,500.00 Possession of a Controlled Substance with a bond of \$4,500.00

Mr. Ardrey and the Deputy were not injured during this event. The Sturgeon Officer transported himself to the hospital for non-life threatening injuries.
