## Media Release

Incident: Man Arrested for Child Pornography by Cyber Crimes

Location: 4504 Nick Court, Columbia, Missouri

Case Number: 2014-4865

### Details:

On Wednesday, October 29, 2014, a 30 year old Columbia resident Jonathan Hillyard was arrested by the Boone County Sheriff's Department Cyber Crimes Task Force stemming from an investigation involving child pornography.

The investigation began in mid-September 2014 when an investigator with the Boone County Sheriff's Department Cyber Crimes Task Force received a CyberTip report from the National Center for Missing Exploited Children. The National Center is a clearing house for online providers to report crimes against children through the Internet. The National Center reported a person they believed to be in the Columbia, Missouri area using an e-mail account to possess child pornography.

Furthermore, a subsequent investigation led the Task Force investigator to identify the owner of the account as Jonathan Hillyard from Columbia, Missouri. The investigator located additional child pornography images on the suspect's email account.

On October 29, 2014, detectives with Cyber Crimes Task Force served a court ordered search on the suspect's residence, seizing numerous items of evidence including several computers. Based on statements received from the suspect, the suspect was arrested for the possession of child pornography.

Arrested was 30 year old Jonathan R. Hillyard, 4504 Nick Court, Columbia, Missouri for Possession of Child Pornography, less than 20 images. At the time of this release the suspect remains in the Boone County Jail pending the posing of a \$10,000 cash bond.

Due to a system failure a photo of Jonathan Hillyard is not available at this time.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, and the University of Missouri Police Department.
