Incident: Woman Arrested for Child Pornography

Location: 104 Moniteau Street, Rocheport, Missouri

Case Number: 2015-1030

Details:

On Wednesday, March 4, 2015, a 47 year old Rocheport resident Marjorie Newell was arrested by the Boone County Sheriff's Department Cyber Crimes Task Force stemming from an investigation involving child pornography.

The investigation began on February 9, 2015 when the Task Force had learned a subject identified as Marjorie Newell was communicating with a subject in the St. Louis, Missouri area.

On March 4, 2015 the Task Force, along with the St. Louis County Special Investigations Unit interviewed the suspect at the Sheriff's Department. During the interview, the suspect admitted to talking with a St. Louis mother who has a 14 year old daughter and arrangements were made so the suspect and another male subject would meet to engage in sexual conduct with the 14 year old. During the interview, the suspect admitted to be in possession of photos of children that the male subject had sent her by text messages.

A Task Force forensic examiner previewed the suspect's cell phone. The examination located several photos of children that appeared to be under 14 years old engaging in sexually explicit conduct.

Arrested was 47 year old Marjorie Newell, 104 Moniteau Street, Rocheport, Missouri for Possession of Child Pornography 1st degree. At the time of this release the suspect bonded March 4, 2015 from the Boone County Jail on \$4500.00.

This investigation is a perfect example of two Internet Crimes Task Force units in Missouri working together to protect Missouri children through the Internet.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, and the University of Missouri Police Department.
