Details:

On Tuesday, May 31, 2016 the Boone County Sheriff's Department Cyber Crimes Task Force arrested a 40 year old Boone County man for attempted sexual exploitation of a minor and attempted sexual misconduct involving a child which was a 13 year old.

The investigation leading to this arrest began late April 2016 when the suspect started conversing with an adult Boone County female through email who he believed had a 13 year old female daughter. The mom and child actually was an undercover detective with the Cyber Crimes Task Force. After exchanging several emails with the mom, the suspect wanted to converse with the child through electronic means. While communicating with the decoy child the suspect solicited the child for nude images and then exposed his genitals to the 13 year old child through text messages.

The suspect is identified as 40 year old Jeremy David Rogers of 1841 Riviera Drive, Columbia, Missouri. The suspect was arrested on suspicion of Attempted Sexual Exploitation of a Child (Class B) and Attempted Sexual Misconduct involving a Child (Class D). The bond is set at \$4500.00 for the Attempted Sexual Misconduct and to be set bond on the Attempted Sexual Exploitation of a Minor.

All suspects are considered innocent until proven guilty in a court of law.

The Boone County Sheriff's Department Cyber Crimes Task Force is comprised of investigators from the Boone County Sheriff's Department, the University of Missouri Police Department and the Federal Bureau of Investigation.
