Incident: Attempted Enticement of a Child, Att. Sexual Misconduct of a Child, Poss. of Drug Paraphernalia, Poss. of Ctrl Substance –under 35 grams

Location: Columbia, Missouri

Details:

On Thursday, June 9, 2016, the Boone County Sheriff's Department Cyber Crimes Task Force arrested a 22 year old Boone County man for traveling to a predetermined location in Columbia, Missouri to have sex with a 14 year old male.

The investigation leading to this arrest began less than 24 hours ago on June 8th when the suspect started conversing with a 14 year old Boone County male juvenile through email. The child actually was an undercover detective with the Cyber Crimes Task Force. After exchanging several emails with the decoy, the suspect wanted to meet at a convenience store in Columbia so he could pick the child up to engage in sexual conduct. During the course of the conversations the suspect is alleged to have sent the decoy child an image of his penis.

The suspect is identified as 22 year old Zachary Davis of 3705 Forum Blvd, Columbia, Missouri. The suspect was arrested on suspicion of Attempted Enticement of a Child (To be set Bond), Attempted Sexual Misconduct involving a Child (\$4500 bond), Poss. of Controlled Substance under 35 grams (Bond \$500), and Poss. of Drug Paraphernalia (Bond \$500).
